14	Section 1. Section 2106 of the act of March 4, 1971 (P.L.6,
15	No.2), known as the Tax Reform Code of 1971, is amended to read:
16	Section 2106. Imposition of TaxAn inheritance tax for the
17	use of the Commonwealth is imposed upon every transfer <u>that</u>
18	exceeds two hundred and fifty thousand dollars (\$250,000) and is
19	subject to tax under this article at the rates specified in
20	section 2116.
21	Section 2. This act shall take effect in 60 days.
