AN ACT

- 1 Providing for the taxation or the exemption from taxation of
- amounts and events relating to the Pennsylvania ABLE Savings
- 3 Program.
- 4 The General Assembly of the Commonwealth of Pennsylvania
- 5 hereby enacts as follows:
- 6 Section 1. Short title.
- 7 This act shall be known and may be cited as the Pennsylvania
- 8 ABLE Savings Program Tax Exemption Act.
- 9 Section 2. Definitions.
- 10 The following words and phrases when used in this act shall
- 11 have the meanings given to them in this section unless the
- 12 context clearly indicates otherwise:
- 13 "Account." An ABLE savings account as defined in section 102
- 14 of the Pennsylvania ABLE Act.
- "Designated beneficiary." The term shall have the same
- 16 meaning as provided in section 102 of the Pennsylvania ABLE Act.
- 17 "Eligible individual." The term shall have the same meaning

- 1 as provided in section 102 of the Pennsylvania ABLE Act.
- 2 "Internal Revenue Code." The Internal Revenue Code of 1986
- 3 (Public Law 99-514, 26 U.S.C. § 1 et seq.).
- 4 "Pennsylvania ABLE Act." The act of April 18, 2016 (P.L.128,
- 5 No.17), known as the Pennsylvania ABLE Act.
- 6 "Pennsylvania ABLE Savings Program." The program established
- 7 under the Pennsylvania ABLE Act.
- 8 "Qualified disability expense." The term shall have the same
- 9 meaning as provided in section 102 of the Pennsylvania ABLE Act.
- 10 "Rollover distribution." The term shall have the same
- 11 meaning as provided in section 102 of the Pennsylvania ABLE Act.
- 12 Section 3. Contributions and distributions.
- 13 (a) Exemption. -- Subject to subsection (b), the following
- 14 shall be exempt from all taxation by the Commonwealth and its
- 15 political subdivisions:
- 16 (1) Undistributed earnings on an account.
- 17 (2) A rollover distribution that is excludable from tax
- 18 under section 529A(c) of the Internal Revenue Code.
- 19 (3) An amount distributed from an account that is
- 20 excludable from tax under section 529A(c) of the Internal
- 21 Revenue Code.
- 22 (b) Deduction.--
- 23 (1) An amount paid as a contribution into an account
- 24 shall be deductible from taxable income on the annual
- 25 personal income tax return.
- 26 (2) The amount paid as a contribution to an account
- 27 allowable as a deduction under this section shall be subject
- 28 to an annual limitation not to exceed the threshold for
- exclusion from gifts as provided in section 2503(b) of the
- 30 Internal Revenue Code, per designated beneficiary.

- 1 (3) The deduction shall not result in taxable income
- 2 being less than zero.
- 3 (c) Tax.--An amount that is distributed from an account and
- 4 not described as exempt from taxation under this section shall
- 5 be taxable under Article III of the act of March 4, 1971 (P.L.6,
- 6 No.2), known as the Tax Reform Code of 1971.
- 7 (d) Change of beneficiary. -- A change in designated
- 8 beneficiaries under section 529A(c) of the Internal Revenue Code
- 9 shall not constitute a taxable event.
- 10 Section 4. Effective date.
- 11 This act shall take effect immediately.
