AN ACT

- Establishing the Donated Dental Services Program; imposing duties on the Department of Health; providing for program
- administration and for contract requirements; and making an
- 4 appropriation.
- 5 The General Assembly of the Commonwealth of Pennsylvania
- 6 hereby enacts as follows:
- 7 Section 1. Short title.
- 8 This act shall be known and may be cited as the Donated
- 9 Dental Services Act.
- 10 Section 2. Definitions.
- 11 The following words and phrases when used in this act shall
- 12 have the meanings given to them in this section unless the
- 13 context clearly indicates otherwise:
- 14 "Department." The Department of Health of the Commonwealth.
- 15 "Program." The Donated Dental Services Program established
- 16 in section 3.
- 17 Section 3. Establishment of program.

- 1 The Donated Dental Services Program is established.
- 2 Section 4. Maintenance of program.
- 3 The department, in consultation with the Dental Lifeline
- 4 Network or its designee, shall maintain the program through
- 5 which volunteer dentists provide comprehensive dental care for
- 6 needy, disabled, aged and medically compromised individuals who
- 7 cannot afford necessary treatment but are ineligible for public
- 8 assistance. Eliqible individuals may be treated by the volunteer
- 9 dentists in their private offices or other appropriate
- 10 locations. Eligible individuals may not be required to pay a fee
- 11 or cost.
- 12 Section 5. Program administration.
- To administer the program, the department shall contract with
- 14 the Dental Lifeline Network or its designee who must be
- 15 experienced in providing similar services or programs.
- 16 Section 6. Contract requirements.
- 17 The contract shall specify the responsibilities of the
- 18 administering organization that may include:
- 19 (1) The maintenance of a network of volunteer dentists,
- 20 including dental specialists, volunteer dental laboratories
- 21 and other appropriate volunteer professionals, to donate
- 22 dental services to eligible individuals.
- 23 (2) The maintenance of a system to refer eligible
- individuals to appropriate volunteers.
- 25 (3) The continuance and implementation of a public
- awareness campaign to educate eligible individuals about the
- availability of the program.
- 28 (4) Providing appropriate administrative and technical
- 29 support to the program.
- 30 (5) Submitting an annual report to the department that:

- 1 (i) Accounts for program funds.
- 2 (ii) Reports the number of individuals served by the
- 3 program and the number of dentists and dental
- 4 laboratories participating as providers in the program.
- 5 (iii) Other information required by the department.
- 6 (6) Performing, as required by the department, another
- 7 duty relating to the program.
- 8 Section 19. Appropriation.
- 9 The sum of \$150,000, or as much thereof as may be necessary,
- 10 is appropriated to the department for the fiscal year July 1,
- 11 2013, to June 30, 2014, to carry out the provisions of this act.
- 12 Section 20. Effective date.
- 13 This act shall take effect immediately.
