## AN ACT

Amending the act of February 22, 1855 (P.L.46, No.50), entitled "An act to incorporate the Farmers' High School of 2 Pennsylvania," further providing for management by board of 3 trustees, for membership of board of trustees, name and style of board and power of board to take and dispose of property 5 and for first meeting of trustees, term of office and 6 election to choose successors. 7 The General Assembly of the Commonwealth of Pennsylvania 8 hereby enacts as follows: 10 Section 1. Sections 2, 3 and 5 of the act of February 22, 1855 (P.L.46, No.50), entitled "An act to incorporate the 11 Farmers' High School of Pennsylvania," are amended to read: 12 13 Section 2. Management by board of trustees 14 The said institution shall be under the management and government of a board of trustees[, of whom there shall be 15 16 thirteen, and seven of whom shall be a quorum, competent to 17 perform the duties hereinafter authorized and required.]. The 18 following apply: 19 (1) The board of trustees shall be composed of thirty-seven trustees, which shall include thirty-four voting trustees and 20

- 1 three nonvoting trustees who serve ex officio. The composition
- 2 of the board of trustees shall be as follows:
- 3 (i) The Governor, the Secretary of Education and the
- 4 <u>Secretary of Agriculture shall serve as the ex officio members</u>
- 5 of the board of trustees.
- 6 (ii) Twelve of the trustees shall be designated Commonwealth\_
- 7 <u>trustees and appointed as follows:</u>
- 8 (A) Four of the trustees shall be appointed by the Governor,
- 9 with the advice and consent of two-thirds of all of the members
- 10 of the Senate.
- 11 (B) Four of the trustees shall be appointed by the President
- 12 pro tempore of the Senate.
- (C) Four of the trustees shall be appointed by the Speaker
- 14 <u>of the House of Representatives.</u>
- 15 (D) Within six months after the effective date of this
- 16 clause, for each of the appointing authorities under this
- 17 subparagraph, one appointment shall be made for a term of four
- 18 years, one appointment shall be made for a term of three years,
- 19 one appointment shall be made for a term of two years and one
- 20 appointment shall be made for a term of one year. Annually
- 21 thereafter, for each of the appointing authorities under this
- 22 subparagraph, one appointment shall be made for a term of four
- 23 years.
- 24 (iii) Twenty-two trustees shall be elected annually under
- 25 the terms and conditions as provided by the by-laws of the
- 26 institution.
- 27 (2) The Lieutenant Governor, Attorney General, Auditor
- 28 General, State Treasurer and the President of The Pennsylvania
- 29 State University shall be prohibited from serving on the board
- 30 of trustees during their terms of office.

- 1 (3) A simple majority of the voting members of the board of
- 2 trustees shall constitute a quorum and shall be required prior
- 3 to any official action to be taken by the board of trustees.
- 4 Section 3. [Membership of board of trustees; name] Name and
- 5 style of board of trustees; power of board to take and dispose
- 6 of property
- 7 The [Governor, Secretary of the Commonwealth, the President
- 8 of the Pennsylvania State Agricultural Society, and the
- 9 principal of the institution, shall each be ex officio a member
- 10 of the board of trustees, which said trustees, and their
- 11 successors in office, are hereby elected and declared to be]
- 12 board of trustees shall be a body politic and corporate in law,
- 13 with perpetual succession, by the name, style and title of the
- 14 Farmers' High School of Pennsylvania, by which name and title
- 15 the said trustees, and their successors, shall be able and
- 16 capable in law to take by gift, grant, sale or conveyance, by
- 17 bequest, devise or otherwise, any estate in any lands, tenements
- 18 and hereditaments, goods, chattels or effects, and at pleasure
- 19 to alien or otherwise dispose of the same to and for the uses
- 20 and purposes of the said institution: provided, however, that
- 21 the annual income of the said State, so held, shall at no time
- 22 exceed twenty-five thousand dollars; and the said corporation
- 23 shall by the same name have power to sue and be sued, and
- 24 generally to do and transact all and every business touching or
- 25 concerning the premises, or which shall be necessarily
- 26 incidental thereto, and to hold, enjoy and exercise all such
- 27 powers, authorities and jurisdiction as are customary in the
- 28 colleges within this Commonwealth.
- 29 [Section 5. First meeting of trustees; term of office;
- 30 election to choose successors

- 1 At the first meeting of the board of trustees, the nine names
- 2 who are not ex officio members, shall by themselves and by lot
- 3 be divided into three classes, of three each, numbered one, two,
- 4 and three; the appointment hereby made of class number one shall
- 5 terminate on the first Monday of October, 1856, number two on
- 6 the first Monday of October, 1857, and number three on the first
- 7 Monday of October, 1858; and upon the termination of the office
- 8 of such directors, to-wit: on the first Monday of October in
- 9 every year, an election shall be held at the institution to
- 10 supply their place, and such election shall be determined by the
- 11 votes of the members of the executive committee of the
- 12 Pennsylvania State Agricultural Society, and the votes of three
- 13 representatives duly chosen by each county agricultural society
- 14 in this Commonwealth, which shall have been organized at least
- 15 three months preceding the time of election, and it shall be the
- 16 duty of the said board of trustees to appoint two of their
- 17 number as judges to hold the said election, to receive and count
- 18 the votes, and return the same to the board of trustees, with
- 19 their certificate of the number of votes cast, and for whom,
- 20 whereupon the said board shall determine who have received the
- 21 highest number of votes, and who are thereby elected.]
- 22 Section 2. All acts or parts of acts are repealed to the
- 23 extent that they are inconsistent with this act.
- 24 Section 3. This act shall take effect in 60 days.
