AN ACT

1 Amending Title 61 (Prisons and Parole) of the Pennsylvania
 2 Consolidated Statutes, in Pennsylvania Board of Probation and
 3 Parole, further providing for parole power.

4 The General Assembly of the Commonwealth of Pennsylvania
 5 hereby enacts as follows:

6 Section 1. Section 6137(k) of Title 61 of the Pennsylvania
 7 Consolidated Statutes is amended and the section is amended by
 8 adding subsections to read:

9 § 6137. Parole power.

10 * * *

11 (f.1) Violent offenses while incarcerated.--The board may
 12 not release on parole a person convicted of a violent offense
 13 committed while incarcerated for at least 24 months following
 14 the expiration of the minimum term of imprisonment fixed by the
 15 court or 24 months following the conviction, whichever is
 16 longer.

17 (f.2) Obstruction of justice offenses while incarcerated.--
 18 The board may not release on parole a person convicted of an

1 obstruction of justice offense committed while incarcerated for
2 at least 12 months following the expiration of the minimum term
3 of imprisonment fixed by the court or 12 months following the
4 conviction, whichever is longer.

6 (k) Definitions.--The following words and phrases shall have
7 the meanings given to them in this subsection unless the context
8 clearly indicates otherwise:

9 "Crime of violence." As defined in 42 Pa.C.S. § 9714(g)
10 (relating to sentences for second and subsequent offenses).

11 "Eligible offender." As defined in section 4503 (relating to
12 definitions).

13 "Obstruction of justice offense." An act, conspiracy or
14 solicitation to commit any of the following offenses under 18
15 Pa.C.S. (relating to crimes and offenses):

16 Section 4952 (relating to intimidation of witnesses or
17 victims).

18 Section 4953 (relating to retaliation against witness,
19 victim or party).

20 Section 4958 (relating to intimidation, retaliation or
21 obstruction in child abuse cases).

22 Section 5121 (relating to escape).

23 Section 5122 (relating to weapons or implements for
24 escape).

25 Section 5123 (relating to contraband).

26 "Violent offense." An act, conspiracy or solicitation to
27 commit any of the following offenses under 18 Pa.C.S.:

28 Section 2501 (relating to criminal homicide).

29 Section 2702 (relating to aggravated assault).

30 Section 2702.1 (relating to assault of law enforcement

1 officer).

2 Section 2703 (relating to assault by prisoner).

3 Section 2703.1 (relating to aggravated harassment by
4 prisoner).

5 Section 2718 (relating to strangulation).

6 Section 3121 (relating to rape).

7 Section 3123 (relating to involuntary deviate sexual
8 intercourse).

9 Section 3124.1 (relating to sexual assault).

10 Section 3124.2 (relating to institutional sexual
11 assault).

12 Section 3125 (relating to aggravated indecent assault).

13 Section 3126 (relating to indecent assault).

14 Section 3301 (relating to arson and related offenses).

15 Section 5501 (relating to riot).

16 Section 2. The addition of 61 Pa.C.S. § 6137(f.1) and (f.2)
17 shall only apply to individuals who are incarcerated for crimes
18 committed on or after the effective date of this section.

19 Section 3. This act shall take effect as follows:

20 (1) The following shall take effect immediately:

21 (i) This section.

22 (ii) Section 2 of this act.

23 (2) The remainder of this act shall take effect in 60
24 days.
