AN ACT

- 1 Providing for the Prescription Drug Pricing Task Force.
- 2 The General Assembly of the Commonwealth of Pennsylvania
- 3 hereby enacts as follows:
- 4 Section 1. Short title.
- 5 This act shall be known and may be cited as the Prescription
- 6 Drug Pricing Task Force Act.
- 7 Section 2. Findings.
- 8 The General Assembly finds that:
- 9 (1) Residents of this Commonwealth have experienced
- 10 increasingly costly out-of-pocket expenses for prescription
- 11 drugs.
- 12 (2) Rising costs for prescription drugs too frequently
- 13 result in a patient's inability to pay for prescriptions and
- subsequently not filling their prescription, cutting pills in
- 15 half or skipping doses.
- 16 (3) Despite the needed financial assistance offered by

- drug manufacturers to help patients pay for prescription
- 2 drugs, many patients cannot afford the mounting costs of
- 3 prescriptions.
- 4 (4) The Commonwealth must examine ways to create
- 5 fairness and address high costs for patients.
- 6 Section 3. Prescription Drug Pricing Task Force.
- 7 (a) Establishment. -- The Prescription Drug Pricing Task Force
- 8 is established to study the pricing of prescription drugs and
- 9 issue a report under this act.
- 10 (b) Composition. -- The task force shall consist of the
- 11 following members, all of whom shall be residents of this
- 12 Commonwealth:
- 13 (1) One member appointed by the Governor.
- 14 (2) One member appointed by the President pro tempore of
- 15 the Senate.
- 16 (3) One member appointed by the Majority Leader of the
- 17 Senate.
- 18 (4) One member appointed by the Minority Leader of the
- 19 Senate.
- 20 (5) One member appointed by the Speaker of the House of
- 21 Representatives.
- 22 (6) One member appointed by the Majority Leader of the
- 23 House of Representatives.
- 24 (7) One member appointed by the Minority Leader of the
- 25 House of Representatives.
- 26 (8) The Insurance Commissioner or a designee.
- 27 (9) The Secretary of Health or a designee.
- 28 (10) The Secretary of Aging or a designee.
- 29 (11) The Secretary of Human Services or a designee.
- 30 (c) Appointment of members. -- The following shall apply:

- 1 (1) Each member appointed to the task force shall be
- 2 knowledgeable of the issues surrounding consumer protection,
- 3 health care, health care costs and health insurance and
- 4 shall, to the greatest extent possible, include individuals
- 5 who represent pharmacies, pharmacy benefit managers, patient
- 6 advocacy groups, pharmaceutical manufacturers, health
- 7 insurers or licensed health care providers.
- 8 (2) A member of the task force may be a member of the
- 9 General Assembly.
- 10 (3) Appointments to the task force shall be made not
- 11 less than 30 days after the effective date of this section.
- 12 Any vacancy shall be filled by the appointing authority.
- 13 (4) The members of the task force shall elect a member
- 14 to serve as chairperson of the task force.
- 15 (d) Expenses.--Members may not receive compensation for
- 16 their service but shall be reimbursed for all necessary travel
- 17 and other reasonable expenses incurred in connection with the
- 18 performance of their duties as members of the task force.
- 19 Section 4. Meetings of the task force.
- 20 (a) First meeting. -- The task force shall hold its first
- 21 meeting within 60 days of the effective date of this section.
- 22 (b) Number of meetings. -- The task force shall meet at least
- 23 four times throughout the course of the year beginning on the
- 24 date of the first meeting and, subject to the approval of the
- 25 chairperson, may hold additional meetings whenever necessary to
- 26 discharge its duties.
- 27 (c) Teleconferencing. -- The task force may participate in
- 28 meetings via teleconference when necessary.
- 29 (d) Call of the chairperson. -- The task force shall hold
- 30 meetings at the call of the chairperson.

- 1 (e) Location. -- The task force shall determine the location
- 2 of meetings, subject to the approval of the chairperson, which
- 3 shall be within this Commonwealth.
- 4 (f) Meetings open to public. -- Each meeting of the task force
- 5 shall be open to the public, subject to the provisions of 65
- 6 Pa.C.S. Ch. 7 (relating to open meetings).
- 7 Section 5. Report.
- 8 (a) Issuance. -- The task force shall research the pricing of
- 9 prescription drugs in this Commonwealth and issue a report
- 10 within one year of its first meeting.
- 11 (b) Contents. -- The report shall include findings,
- 12 recommendations and any suggested legislative remedies regarding
- 13 the following:
- 14 (1) Efforts to make prescription drugs more affordable.
- 15 (2) Factors contributing to high out-of-pocket
- 16 prescription drug costs to patients.
- 17 (3) Patient treatment adherence and access to
- 18 prescription drugs.
- 19 (4) Expensive medical interventions or hospitalizations
- that may occur as a result of a patient's inability to afford
- and maintain access to prescription drugs.
- 22 (5) Manufacturer costs for research and development,
- 23 clinical trials, regulatory costs, cost of materials,
- 24 manufacturing and administration.
- 25 (6) Manufacturer annual prices for prescription drugs to
- 26 purchasers inside and outside of the United States.
- 27 (7) Profit margins and projected profit margins of drug
- 28 manufacturers.
- 29 (8) Financial assistance offered by drug manufacturers.
- 30 (9) Further oversight, transparency and clarity

- 1 concerning the determination of prescription drug pricing.
- 2 (10) Negotiation of prescription drug costs between
- 3 manufacturers and the Pennsylvania medical assistance
- 4 program.
- 5 (c) Consultation. -- The task force shall consult with
- 6 interested parties, experts and members of the public during the
- 7 process of compiling the report.
- 8 (d) Transmittal.--The report shall be transmitted to the
- 9 following:
- 10 (1) The Governor.
- 11 (2) The Department of Aging of the Commonwealth.
- 12 (3) The Department of Health of the Commonwealth.
- 13 (4) The Department of Human Services of the
- 14 Commonwealth.
- 15 (5) The Insurance Department of the Commonwealth.
- 16 (6) The Health Care Cost Containment Council.
- 17 (7) The chairperson and minority chairperson of the
- 18 Aging and Youth Committee of the Senate.
- 19 (8) The chairperson and minority chairperson of the
- 20 Aging and Older Adult Services Committee of the House of
- 21 Representatives.
- 22 (9) The chairperson and minority chairperson of the
- 23 Banking and Insurance Committee of the Senate.
- 24 (10) The chairperson and minority chairperson of the
- Insurance Committee of the House of Representatives.
- 26 (11) The chairperson and minority chairperson of the
- 27 Health and Human Services Committee of the Senate.
- 28 (12) The chairperson and minority chairperson of the
- 29 Health Committee of the House of Representatives.
- 30 (13) The chairperson and minority chairperson of the

- 1 Human Services Committee of the House of Representatives.
- 2 (14) The United States Food and Drug Administration.
- 3 Section 6. Effective date.
- 4 This act shall take effect immediately.
