9	(a) Offense definedA person commits a summary offense if
10	the person willfully organizes, operates or conducts a trap
11	shoot or block shoot in which live pigeons are used as targets.
12	(b) ApplicabilityNothing under this section shall be
13	construed to apply to activity which is authorized or permitted
14	under 34 Pa.C.S. (relating to game) or a special permit under 58
15	Pa. Code Ch. 147 (relating to special permits) or to the
16	training of dogs for activity which is authorized or permitted
17	<u>under 34 Pa.C.S.</u>
