AN ACT

Amending the act of June 3, 1937 (P.L.1333, No.320), entitled "An act concerning elections, including general, municipal, 1 2 special and primary elections, the nomination of candidates, 3 primary and election expenses and election contests; creating and defining membership of county boards of elections; 5 imposing duties upon the Secretary of the Commonwealth, courts, county boards of elections, county commissioners; 7 imposing penalties for violation of the act, and codifying, 8 9 revising and consolidating the laws relating thereto; and repealing certain acts and parts of acts relating to 10 elections," in preliminary provisions, further providing for 11 definitions; in the Secretary of the Commonwealth, further 12 providing for powers and duties of the Secretary of the 13 Commonwealth; and, in county boards of elections, further 14 providing for powers and duties of county boards. 15 16 The General Assembly of the Commonwealth of Pennsylvania 17 hereby enacts as follows: Section 1. Section 102(z.5) of the act of June 3, 1937 18 19 (P.L.1333, No.320), known as the Pennsylvania Election Code, is 20 amended to read: 2.1 Section 102. Definitions. -- The following words, when used in 22 this act, shall have the following meanings, unless otherwise 23 clearly apparent from the context:

- 1 (z.5) The words "proof of identification" shall mean:
- 2 [(1) In the case of an elector who has a religious objection
- 3 to being photographed, a valid-without-photo driver's license or
- 4 a valid-without-photo identification card issued by the
- 5 Department of Transportation.
- 6 (2) For an elector who appears to vote under section 1210, a
- 7 document that:
- 8 (i) shows the name of the individual to whom the document
- 9 was issued and the name substantially conforms to the name of
- 10 the individual as it appears in the district register;
- 11 (ii) shows a photograph of the individual to whom the
- 12 document was issued;
- 13 (iii) includes an expiration date and is not expired,
- 14 except:
- (A) for a document issued by the Department of
- 16 Transportation which is not more than twelve (12) months past
- 17 the expiration date; or
- (B) in the case of a document from an agency of the Armed
- 19 forces of the United States or their reserve components,
- 20 including the Pennsylvania National Guard, establishing that the
- 21 elector is a current member of or a veteran of the United States
- 22 Armed Forces or National Guard which does not designate a
- 23 specific date on which the document expires, but includes a
- 24 designation that the expiration date is indefinite; and
- (iv) was issued by one of the following:
- 26 (A) The United States Government.
- 27 (B) The Commonwealth of Pennsylvania.
- (C) A municipality of this Commonwealth to an employee of
- 29 that municipality.
- 30 (D) An accredited Pennsylvania public or private institution

- of higher learning.
- 2 (E) A Pennsylvania care facility.
- 3 (3) For a qualified absentee elector under section 1301 or a
- 4 qualified mail-in elector under section 1301-D:
- 5 (i) in the case of an elector who has been issued a current
- 6 and valid driver's license, the elector's driver's license
- 7 number;
- 8 (ii) in the case of an elector who has not been issued a
- 9 current and valid driver's license, the last four digits of the
- 10 elector's Social Security number;
- 11 (iii) in the case of an elector who has a religious
- 12 objection to being photographed, a copy of a document that
- 13 satisfies paragraph (1); or
- (iv) in the case of an elector who has not been issued a
- 15 current and valid driver's license or Social Security number, a
- 16 copy of a document that satisfies paragraph (2).]
- 17 (1) In the case of any elector, at least one of the
- 18 <u>following:</u>
- 19 (i) the elector's driver's license;
- 20 (ii) in the case of an elector who has a religious objection
- 21 to being photographed, a copy of a valid-without-photo driver's
- 22 license or a valid-without-photo identification card issued by
- 23 <u>the Department of Transportation;</u>
- 24 (iii) the elector's voter registration card with scannable
- 25 <u>identification number and a copy of the elector's signature, as</u>
- 26 issued by a county under section 302;
- 27 <u>(iv) a document from an agency of the armed forces of the</u>
- 28 <u>United States or their reserve components, including the</u>
- 29 Pennsylvania National Guard, establishing that the elector is a
- 30 current member of or a veteran of the United States Armed Forces

- 1 or National Guard which does not designate a specific date on
- 2 which the document expires, but includes a designation that that
- 3 <u>expiration date is indefinite;</u>
- 4 (v) a document issued by the secretary under section 201(n);
- 5 (vi) an affidavit provided to an elector by elections
- 6 officers, on which the elector shall affirm his or her identity,
- 7 <u>including his or her signature and the last four digits of his</u>
- 8 or her Social Security number. The affidavit shall include
- 9 disclosure of the penalties under section 1802; or
- 10 (vii) a document that shows the name and photograph of the
- 11 individual to whom the document was issued, includes an
- 12 <u>expiration date and is not expired and is issued by one of the</u>
- 13 <u>following:</u>
- 14 (A) The United States Government.
- 15 (B) The Commonwealth of Pennsylvania.
- (C) A municipality of this Commonwealth to an employe of
- 17 that municipality.
- 18 (D) An accredited public or private institution of higher
- 19 learning located in this Commonwealth.
- 20 (E) A care facility located in this Commonwealth.
- 21 (2) (Reserved).
- 22 * * *
- 23 Section 2. Sections 201 and 302 of the act are amended by
- 24 adding subsections to read:
- 25 Section 201. Powers and Duties of the Secretary of the
- 26 Commonwealth.--The Secretary of the Commonwealth shall exercise
- 27 in the manner provided by this act all powers granted to him by
- 28 this act, and shall perform all the duties imposed upon him by
- 29 this act, which shall include the following:
- 30 * * *

- 1 (i) To provide to any registered elector upon request, and
- 2 free of charge, a durable photo identification card which may be
- 3 <u>used for the purposes of voting.</u>
- 4 Section 302. Powers and Duties of County Boards. -- The county
- 5 boards of elections, within their respective counties, shall
- 6 exercise, in the manner provided by this act, all powers granted
- 7 to them by this act, and shall perform all the duties imposed
- 8 upon them by this act, which shall include the following:
- 9 * * *
- 10 (q) To provide to each registered elector in a county,
- 11 within one year of the effective date of this subsection and
- 12 upon new or updated registration after the effective date of
- 13 this subsection, or at the request of an elector, a durable
- 14 voter registration card, including a scannable identification
- 15 code and a likeness of a registered elector's signature. A
- 16 county board of elections shall investigate the circumstances of
- 17 any registration card returned as undeliverable by the United
- 18 States Postal Service. The investigation shall include
- 19 contacting the applicant, further attempts to have his or her
- 20 registration card delivered and the correction or
- 21 reconsideration of his or her registration status and registered
- 22 address, if they are found to be incorrect.
- 23 Section 3. This act shall take effect in 60 days.
