AN ACT

- Amending the act of April 9, 1929 (P.L.177, No.175), entitled 1 "An act providing for and reorganizing the conduct of the 2 executive and administrative work of the Commonwealth by the 3 Executive Department thereof and the administrative departments, boards, commissions, and officers thereof, including the boards of trustees of State Normal Schools, or 5 6 Teachers Colleges; abolishing, creating, reorganizing or 7 8 authorizing the reorganization of certain administrative departments, boards, and commissions; defining the powers and 9 duties of the Governor and other executive and administrative 10 officers, and of the several administrative departments, 11 boards, commissions, and officers; fixing the salaries of the 12 Governor, Lieutenant Governor, and certain other executive 13 and administrative officers; providing for the appointment of 14 certain administrative officers, and of all deputies and 15 other assistants and employes in certain departments, boards, 16 and commissions; providing for judicial administration; and 17 prescribing the manner in which the number and compensation 18 of the deputies and all other assistants and employes of 19 certain departments, boards and commissions shall be 20 determined," in powers and duties of the Department of Health 21 22 and its departmental administrative and advisory boards, 23 providing for disaster emergencies.

- 25 hereby enacts as follows:
- 26 Section 1. The act of April 9, 1929 (P.L.177, No.175), known
- 27 as The Administrative Code of 1929, is amended by adding a

- 2 <u>Section 2106.1. Disaster Emergencies.--If a declaration of a</u>
- 3 disaster emergency under 35 Pa.C.S. § 7301(b) (relating to
- 4 <u>general authority of Governor) requires the Governor to order</u>
- 5 the closure of non-life-sustaining businesses in this
- 6 Commonwealth, the Department of Health, in conjunction with the
- 7 Governor, shall utilize the Essential Critical Infrastructure
- 8 Workforce advisory list developed by the Cybersecurity and
- 9 <u>Infrastructure Security Agency of the United States Department</u>
- 10 of Homeland Security in determining whether a business is life-
- 11 sustaining. All businesses shall be provided with the ability to
- 12 continue operations in some manner or form. This section shall
- 13 apply during the continuance of a state of disaster emergency
- 14 declared before, on or after the effective date of this section.
- 15 Section 2. This act shall take effect immediately.
