AN ACT

- 1 Amending Title 25 (Elections) of the Pennsylvania Consolidated
- Statutes, in voting procedures, further providing for
- application for absentee ballots.
- 4 The General Assembly of the Commonwealth of Pennsylvania
- 5 hereby enacts as follows:
- 6 Section 1. Section 3302(a) of Title 25 of the Pennsylvania
- 7 Consolidated Statutes is amended and the section is amended by
- 8 adding subsections to read:
- 9 § 3302. Application for absentee ballots.
- 10 (a) General rule. -- Notwithstanding the provisions of Part IV
- 11 (relating to voter registration) or the act of June 3, 1937
- 12 (P.L.1333, No.320), known as the Pennsylvania Election Code,
- 13 [the following persons] any qualified elector may make
- 14 application for an absentee ballot by sending a letter or other
- 15 signed document to or by appearing in person in accordance with
- 16 <u>subsection (e) at</u> the county board of elections in the county in
- 17 which the person's voting address is located[:].

- 1 [(1) A registered elector who is unable to attend the
- 2 polling place on the day of any primary or election because
- 3 of illness or physical disability.
- 4 (2) A registered elector who expects to be absent from
- 5 this Commonwealth or the municipality of residence because
- duties, occupation or business require the elector to be
- 7 elsewhere the day of any primary or election.
- 8 (3) A county employee who cannot vote due to duties
- 9 relating to the conduct of elections.
- 10 (4) A person who will not attend a polling place because
- of an observance of a religious holiday.]

- (e) In-person appearance. -- Any qualified elector who appears
- 14 <u>during normal business hours at a county board of elections in</u>
- 15 the county in which the person's voting address is located shall
- 16 be permitted to, at that time, apply for an absentee ballot,
- 17 complete the application, submit the application, receive and
- 18 complete the ballot and cast the ballot, subject to review and
- 19 approval of the application in accordance with law.
- 20 (f) Reason for requesting absentee ballot. -- No qualified
- 21 elector who submits an application for an absentee ballot may be
- 22 required to state the reason for the absentee ballot.
- 23 Section 2. This act shall take effect immediately.
