- (C) If the subject land consists of 100 or more 24 acres, the wind power generation system may be 25 constructed on no more than two acres of the subject 26 land, plus two additional acres for every 50 acres by 27 which the subject land exceeds 100 acres.
 - (D) If the subject land upon which the wind power generation system is constructed is subsequently subdivided or conveyed or transferred in
