AN ACT

Establishing the Heritage Area Program to identify, protect, 2 enhance and promote the historic, recreational, natural, cultural and scenic resources of this Commonwealth and to stimulate community revitalization and economic development through regional heritage conservation, recreation, tourism 6 and partnerships; and repealing provisions in The Fiscal Code relating to heritage areas. Short title. <--39 This act shall be known and may be cited as the Heritage Area 40 Program Act. 41 Section 2. Declaration of policy. 42 The General Assembly finds and declares as follows: 43 (1) The act of June 28, 1995 (P.L.89, No.18), known as

the Conservation and Natural Resources Act, created the

Department of Conservation and Natural Resources and
empowered the department to administer State heritage
conservation programs, such as the Pennsylvania Heritage
Parks Program.

- (2) The Pennsylvania Heritage Parks Program consists of heritage areas, which are multicounty regions located in this Commonwealth and designated by gubernatorial action that promotes an appreciation of the history and heritage of the regions.
- (3) Since 1989, heritage areas assist communities in developing, restoring, preserving and conserving nationally, State and locally significant historic, cultural, natural and recreational resources through capital and programmatic investments.
- (4) Heritage areas have successfully demonstrated the ability to create public, private and nonprofit investment partnerships leveraging significant investments for every dollar of Commonwealth funds.
- (5) Heritage areas are a key catalyst in regions of this Commonwealth for economic growth and community development strategies and investments resulting in tourism promotion, small business development and the creation of jobs.
- (6) The Commonwealth's program has long been recognized, studied and replicated by other states and the National Park—Service as a model for successful heritage and community conservation and development.
- (7) Due to the success of the program, a targeted effort—should be made to promote this Commonwealth's heritage areas—by providing dedicated funding.
- 30 Section 3. Definitions.

- 1 The following words and phrases when used in this act shall
- 2 have the meanings given to them in this section unless the
- 3 context clearly indicates otherwise:
- 4 "Department." The Department of Conservation and Natural
- 5 Resources of the Commonwealth.
- 6 "Heritage area." A Commonwealth-designated region, managed
- 7 by a nonprofit organization or governmental entity, which
- 8 conserves nationally and State significant landscapes and
- 9 develops, protects, interprets and promotes its historic,
- 10 cultural, natural and recreational resources to stimulate
- 11 economic and community development.
- 12 "Program." The Heritage Area Program.
- 13 "Secretary." The Secretary of the Department of Conservation
- 14 and Natural Resources of the Commonwealth.
- 15 Section 4. Heritage Area Program.
- 16 (a) Establishment. The Heritage Area Program is established
- 17 within the department to identify, protect, develop, enhance and
- 18 promote the historic, recreational, natural, cultural and scenic
- 19 resources of this Commonwealth and to stimulate community
- 20 revitalization and economic development through regional
- 21 heritage conservation, recreation, tourism and partnerships.
- 22 (b) Administration. --
- 23 (1) The department shall adopt program guidelines and
- 24 policies for the implementation and administration of the
- 25 program.
- 26 (2) The department shall consult with the heritage areas
- 27 on an annual basis to discuss program goals, guidelines and
- 28 policies.
- 29 (c) Funding. The department shall, under subsection (f),
- 30 allocate funds appropriated to the department to the program for-

- 1 the following purposes:
- 2 (1) Management, administration, operation and marketing
- 3 of heritage areas.
- 4 (2) Planning, implementation, technical assistance and educational projects and programs related to heritage areas.
- 6 (3) Development, construction, rehabilitation, repair,
 7 acquisition, preservation and enhancement of lands, buildings
- 8 and other structures related to heritage areas.
- 9 (4) Protection, documentation, interpretation and
 10 promotion of the cultural, natural, scenic, recreational and
 11 historic resources of heritage areas.
- 12 (5) Establishment of partnerships and coalitions of

 13 governmental and nongovernmental agencies and organizations

 14 to assist heritage areas with the implementation of

 15 management action plans.
- 16 (6) Any other activities deemed appropriate by the department.
- 18 (d) Use. A heritage area may use the funding allocated by
- 19 the department for the program to provide a grant to another
- 20 entity and organization, including a county, municipality,
- 21 authority, nonprofit organization, other authorized
- 22 organization, private sector firm and business, if the purpose-
- 23 of the grant meets the requirements of subsection (c).
- 24 (e) Eligibility. In addition to any other funding provided
- 25 to a heritage area, a heritage area shall be eligible to apply
- 26 for a grant and loan program administered by the department or
- 27 other Federal or State agency or entity.
- 28 (f) Amount.--
- 29 (1) The department shall distribute funds to the program
- 30 based on established program goals, guidelines and policies.

- 1 (2) The department shall allocate all funds appropriated
- 2 annually for the program and each State designated heritage
- 3 area shall receive a minimum amount established by the
- 4 program goals, guidelines and policies.
- 5 (g) Administrative use. The department may use no more than
- 6 5% of the funding appropriated annually for the program for
- 7 administrative expenses, including the development of a
- 8 strategic plan or other appropriate initiative related to the
- 9 administration of the program.
- 10 Section 5. Repeal and continuation.
- 11 (a) Repeal. -- Repeals are as follows:
- 12 (1) The General Assembly declares that the repeal under-
- 13 paragraph (2) is necessary to effectuate this act.
- 14 (2) Article XVI-J of the act of April 9, 1929 (P.L.343,
- No.176), known as The Fiscal Code, is repealed.
- 16 (b) Continuation. This act is a continuation of Article
- 17 XVI J of The Fiscal Code. Except as otherwise provided in this
- 18 act, all activities initiated under Article XVI-J of The Fiscal-
- 19 Code shall continue and remain in full force and effect and may
- 20 be completed under this act. Orders, regulations, rules and
- 21 decisions which were made under Article XVI J of The Fiscal Code
- 22 and which are in effect on the effective date of subsection (a)
- 23 (2) shall remain in full force and effect until revoked, vacated
- 24 or modified under this act. Contracts, obligations and
- 25 collective bargaining agreements entered into under Article XVI-
- 26 J of The Fiscal Code are not affected nor impaired by the repeal-
- 27 of Article XVI-J of The Fiscal Code.
