AN ACT

- Amending the act of May 17, 1921 (P.L.682, No.284), entitled "An act relating to insurance; amending, revising, and 2 consolidating the law providing for the incorporation of 3 insurance companies, and the regulation, supervision, and protection of home and foreign insurance companies, Lloyds associations, reciprocal and inter-insurance exchanges, and fire insurance rating bureaus, and the regulation and 7 supervision of insurance carried by such companies, 8 9 associations, and exchanges, including insurance carried by the State Workmen's Insurance Fund; providing penalties; and 10 repealing existing laws," in casualty insurance, providing 11 for health insurance coverage for immunizations administered 12 at a pharmacy by a pharmacist. 13 14 The General Assembly of the Commonwealth of Pennsylvania 15 hereby enacts as follows: Section 1. The act of May 17, 1921 (P.L.682, No.284), known 16 17 as The Insurance Company Law of 1921, is amended by adding a section to read: 18 19 Section 635.8. Coverage for Immunizations Administered at a Pharmacy by a Pharmacist. -- (a) All health insurance policies 20 shall provide coverage for immunizations administered at a 21 22 pharmacy by a pharmacist.
 - (b) As used in this section:

- 1 (1) "Health insurance policy" means a group or individual
- 2 <u>health or sickness or accident insurance policy, subscriber</u>
- 3 contract or certificate issued by an entity. The term does not
- 4 <u>include accident only, fixed indemnity, limited benefit, credit,</u>
- 5 <u>dental</u>, <u>vision</u>, <u>specified disease</u>, <u>Medicare supplement</u>, <u>Civilian</u>
- 6 <u>Health and Medical Program of the Uniformed Services (CHAMPUS)</u>
- 7 <u>supplement, long-term care or disability income, workers'</u>
- 8 <u>compensation or automobile medical payment insurance.</u>
- 9 (2) "Pharmacist" means an individual duly licensed by the
- 10 State Board of Pharmacy to engage in the practice of pharmacy.
- 11 (3) "Pharmacy" means a property issued a permit by the State
- 12 Board of Pharmacy where drugs, devices and diagnostic agents for
- 13 <u>human or animal consumption are stored, dispensed or compounded,</u>
- 14 <u>excluding offices or facilities of veterinarians licensed by the</u>
- 15 State Board of Veterinary Medical Examiners. The term does not
- 16 include the operations of a manufacturer or distributor, as
- 17 defined in the act of April 14, 1972 (P.L.233, No.64), known as
- 18 "The Controlled Substance, Drug, Device and Cosmetic Act." In an
- 19 institution, "pharmacy" means the organized pharmacy services in
- 20 the institution under the direct supervision of a licensed
- 21 pharmacist.
- 22 Section 2. This act shall take effect immediately.
