2 (q) Definitions.--As used in this section, the following 3 words and phrases shall have the meanings given to them in this 4 subsection:

6 "Animal fighting paraphernalia." Any device, implement, 7 object, facility, space or drug used, or intended to be used, 8 for animal fighting, to train an animal for animal fighting or in furtherance of animal fighting. IN DETERMINING WHETHER AN 9 <---10 OBJECT IS ANIMAL FIGHTING PARAPHERNALIA, A COURT OR OTHER 11 AUTHORITY SHOULD CONSIDER STATEMENTS BY AN OWNER OR BY ANYONE IN 12 CONTROL OF THE OBJECT CONCERNING ITS USE, ANY PRIOR CONVICTIONS 13 UNDER FEDERAL OR STATE LAW RELATING TO ANIMAL FIGHTING, THE 14 PROXIMITY OF THE OBJECT IN TIME AND SPACE TO THE DIRECT VIOLATION OF THIS SECTION, DIRECT OR CIRCUMSTANTIAL EVIDENCE OF 15 16 THE INTENT OF THE ACCUSED TO DELIVER THE OBJECT TO PERSONS WHOM 17 HE OR SHE KNOWS OR SHOULD REASONABLY KNOW INTENDS TO USE THE 18 OBJECT TO FACILITATE A VIOLATION OF THIS SECTION, ORAL OR 19 WRITTEN INSTRUCTIONS PROVIDED WITH OR IN THE VICINITY OF THE 20 OBJECT CONCERNING ITS USE, DESCRIPTIVE MATERIALS ACCOMPANYING 21 THE OBJECT WHICH EXPLAIN OR DEPICT ITS USE AND ALL OTHER 22 LOGICALLY RELEVANT FACTORS. 23 * * *
