## AN ACT

- 1 Amending the act of March 10, 1949 (P.L.30, No.14), entitled "An
- act relating to the public school system, including certain
- provisions applicable as well to private and parochial
- schools; amending, revising, consolidating and changing the
- laws relating thereto," in school health services, further
- 6 providing for health services and providing for vision
- 7 screenings and examinations.
- 8 The General Assembly of the Commonwealth of Pennsylvania
- 9 hereby enacts as follows:
- 10 Section 1. Section 1402(a) of the act of March 10, 1949
- 11 (P.L.30, No.14), known as the Public School Code of 1949, is
- 12 amended to read:
- 13 Section 1402. Health Services. -- (a) Each child of school
- 14 age shall be given by methods established by the Advisory Health
- 15 Board, [(1) a vision test by a school nurse, medical technician
- 16 or teacher, ] (2) a hearing test by a school nurse or medical
- 17 technician, (3) a measurement of height and weight by a school
- 18 nurse or teacher, who shall use the measurement to compute a
- 19 child's weight-for-height ratio, (4) tests for tuberculosis
- 20 under medical supervision, and (5) such other tests as the

- 1 Advisory Health Board may deem advisable to protect the health
- 2 of the child. [Vision tests shall be given at least annually and
- 3 other tests at intervals established by the Advisory Health
- 4 Board.]
- 5 \* \* \*
- 6 Section 2. The act is amended by adding a section to read:
- 7 <u>Section 1403.1. Vision Screening and Examinations.--(a) (1)</u>
- 8 Within 30 days of the start of the school year at a public,
- 9 private, parochial or nonpublic school in this Commonwealth,
- 10 <u>including special education and home education programs and</u>
- 11 cyber and charter schools or upon entry into the school
- 12 <u>district</u>, the parent or legal guardian of a child entering
- 13 <u>kindergarten shall present to school health personnel</u>
- 14 <u>certification that the child within the previous twelve months</u>
- 15 passed a vision screening performed by a primary care provider
- 16 or a vision screening conducted by screeners with specific
- 17 training in vision screening techniques and protocols approved
- 18 by the Department of Health or has completed a comprehensive eye
- 19 exam conducted by an ophthalmologist or optometrist.
- 20 (2) The Advisory Health Board shall promulgate regulations
- 21 to establish vision screening standards based on instrument-
- 22 <u>based vision screening technologies or visual acuity testing</u>,
- 23 taking into consideration national guidelines from the American
- 24 Academy of Pediatrics.
- 25 (b) (1) Every school year at a public, private, parochial
- 26 or nonpublic school in this Commonwealth, including special
- 27 education and home education programs and cyber and charter
- 28 schools, until a child completes the fifth grade and every two
- 29 years thereafter until the child graduates from the twelfth
- 30 grade, the child shall have a vision screening performed by

- 1 <u>school health personnel or screeners with specific training in</u>
- 2 <u>vision screening techniques and protocols approved by the</u>
- 3 Advisory Health Board. The results of the vision screening shall
- 4 <u>be supplied to the parent or legal guardian of the child.</u>
- 5 (2) For a child who fails a required vision screening, a
- 6 comprehensive eye examination, performed by an ophthalmologist
- 7 or optometrist, shall also be required. Notification of the
- 8 parent or legal guardian of the failed screening shall be
- 9 accompanied by notification of requirement for a comprehensive
- 10 <u>examination that must be completed within one hundred twenty</u>
- 11 (120) days or before the start of the next school year,
- 12 whichever comes first. Notification should also include a form,
- 13 to be completed by the examining ophthalmologist or optometrist,
- 14 to be used for reporting the results of the examination. The
- 15 report shall include, but not be limited to, the following:
- 16 <u>(i) Date of report.</u>
- 17 (ii) Name, address and date of birth of the child.
- 18 <u>(iii) Name of the child's school.</u>
- 19 (iv) A summary of significant findings, including best
- 20 corrected visual acuity, diagnosis, treatment, prognosis,
- 21 whether or not a return visit is recommended and, if so, when.
- (v) Recommended educational adjustments for the child, if
- 23 any, which may include preferential seating in the classroom,
- 24 eyeglasses for full-time use in school, eyeglasses for part-time
- 25 <u>use in school, sight-saving eyeglasses or any other</u>
- 26 recommendations.
- 27 (vi) Name, address and signature of the examiner.
- 28 (3) The examination report shall be accompanied by an
- 29 envelope for return of the form to school health personnel so
- 30 the completion status and result of the examination may be

- 1 <u>recorded</u>.
- 2 (c) No child shall be excluded from attending school for the
- 3 reason that the parent or quardian failed to furnish a report of
- 4 the child's vision screening or to have an examination completed
- 5 upon failure of vision screening. Parents and quardians that
- 6 <u>fail to present the required report shall be notified in writing</u>
- 7 of the required vision examination every three months until the
- 8 examination completion has been verified.
- 9 Section 3. This act shall take effect in 60 days.
