AN ACT

At least one member shall be a female veteran, and at least 25 26 one member shall be a veteran of the Vietnam era. Members at 27 large shall serve a term of four years and until a successor 28 has been appointed. 29 The State Adjutants of the American Legion, the Disabled American Veterans (DAV) and the Veterans of Foreign 30
