Amending the act of May 19, 1995 (P.L.33, No.3), entitled "An 1 act limiting environmental liability for economic development agencies, financiers and fiduciaries," further providing for 2 3 definitions. 4 5 The General Assembly of the Commonwealth of Pennsylvania 6 hereby enacts as follows: 7 Section 1. The definition of "economic development agencies" in section 3 of the act of May 19, 1995 (P.L.33, No.3), known as 8 the Economic Development Agency, Fiduciary and Lender 10 Environmental Liability Protection Act, is amended to read: 11 Section 3. Definitions. 12 The following words and phrases when used in this act shall 13 have the meanings given to them in this section unless the 14 context clearly indicates otherwise: 15 16 "Economic development [agencies] agency." The term includes: 17 Any redevelopment authority created under the act of May 24, 1945 (P.L.991, No.385), known as the Urban 18

Redevelopment Law, and any nonprofit corporation created and

- 4 defined in the act of May 17, 1956 (1955 P.L.1609, No.537),
- 5 known as the Pennsylvania Industrial Development Authority

- 7 (3) Any industrial and commercial development authority
- 8 created under the act of August 23, 1967 (P.L.251, No.102),
- 9 known as the Economic Development Financing Law.
- 10 (4) Any area loan organization as that term is defined
- 11 in the act of July 2, 1984 (P.L.545, No.109), known as the
- 12 Capital Loan Fund Act.
- 13 (5) Any other Commonwealth or municipal authority which
- 14 acquires title or an interest in property.
- 15 (6) [Municipalities] Any municipality or municipal
- industrial development or community development [departments]
- 17 <u>department</u> organized by ordinance under a home rule charter
- which [buy] buys and [sell] sells land for community
- development purposes.
