A JOINT RESOLUTION

- 1 Proposing an amendment to the Constitution of the Commonwealth
- of Pennsylvania, providing for a Legislative and
- 3 Congressional Reapportionment Bureau for the purpose of
- 4 reapportioning and redistricting the Commonwealth of
- 5 Pennsylvania.
- 6 The General Assembly of the Commonwealth of Pennsylvania
- 7 hereby resolves as follows:
- 8 Section 1. The following amendment to the Constitution of
- 9 Pennsylvania is proposed in accordance with Article XI:
- 10 That section 17 of Article II be amended to read:
- 11 § 17. Legislative [Reapportionment Commission] and
- 12 <u>Congressional Reapportionment Bureau</u>.
- 13 (a) In each year following the year of the Federal decennial
- 14 census, a Legislative [Reapportionment Commission] and
- 15 Congressional Reapportionment Bureau shall be constituted for
- 16 the purpose of reapportioning the Commonwealth. The bureau shall

- 1 consist of a director and employees as are necessary to carry
- 2 out the responsibilities of reapportionment and redistricting.
- 3 [The commission shall act by a majority of its entire
- 4 membership.
- 5 (b) The commission shall consist of five members: four of
- 6 whom shall be the majority and minority leaders of both the
- 7 Senate and the House of Representatives, or deputies appointed
- 8 by each of them, and a chairman selected as hereinafter
- 9 provided. No later than 60 days following the official reporting
- 10 of the Federal decennial census as required by Federal law, the
- 11 four members shall be certified by the President pro tempore of
- 12 the Senate and the Speaker of the House of Representatives to
- 13 the elections officer of the Commonwealth who under law shall
- 14 have supervision over elections.
- The four members within 45 days after their certification
- 16 shall select the fifth member, who shall serve as chairman of
- 17 the commission, and shall immediately certify his name to such
- 18 elections officer. The chairman shall be a citizen of the
- 19 Commonwealth other than a local, State or Federal official
- 20 holding an office to which compensation is attached.
- 21 If the four members fail to select the fifth member within
- 22 the time prescribed, a majority of the entire membership of the
- 23 Supreme Court within 30 days thereafter shall appoint the
- 24 chairman as aforesaid and certify his appointment to such
- 25 elections officer.
- Any vacancy in the commission shall be filled within 15 days
- 27 in the same manner in which such position was originally filled.
- 28 (c) No later than 90 days after either the commission has
- 29 been duly certified or the population data for the Commonwealth
- 30 as determined by the Federal decennial census are available,

- 1 whichever is later in time, the commission shall file a
- 2 preliminary reapportionment plan with such elections officer.
- 3 The commission shall have 30 days after filing the
- 4 preliminary plan to make corrections in the plan.
- 5 Any person aggrieved by the preliminary plan shall have the
- 6 same 30-day period to file exceptions with the commission in
- 7 which case the commission shall have 30 days after the date the
- 8 exceptions were filed to prepare and file with such elections
- 9 officer a revised reapportionment plan. If no exceptions are
- 10 filed within 30 days, or if filed and acted upon, the
- 11 commissions's plan shall be final and have the force of law.
- 12 (d) Any aggrieved person may file an appeal from the final
- 13 plan directly to the Supreme Court within 30 days after the
- 14 filing thereof. If the appellant establishes that the final plan
- 15 is contrary to law, the Supreme Court shall issue an order
- 16 remanding the plan to the commission and directing the
- 17 commission to reapportion the Commonwealth in a manner not
- 18 inconsistent with such order.
- 19 (e) When the Supreme Court has finally decided an appeal or
- 20 when the last day for filing an appeal has passed with no appeal
- 21 taken, the reapportionment plan shall have the force of law and
- 22 the districts therein provided shall be used thereafter in
- 23 elections to the General Assembly until the next reapportionment
- 24 as required under this section 17.]
- 25 (b) (1) The bureau shall acquire appropriate information,
- 26 review and evaluate available facilities and develop programs
- 27 and procedures, which may include the use of mapping software,
- 28 <u>in preparation for drawing congressional and legislative</u>
- 29 redistricting plans on the basis of each Federal census.
- 30 (2) By December 31 of each year ending in zero, the bureau

- 1 shall obtain from the United States Census Bureau information
- 2 regarding geographic and political units in this Commonwealth
- 3 for which Federal census population data has been gathered and
- 4 will be tabulated. The bureau shall use the data obtained to
- 5 prepare:
- 6 (i) Necessary descriptions of geographic and political units
- 7 for which census data will be reported and which are suitable
- 8 for use as components of legislative districts.
- 9 (ii) Maps of counties, cities and other geographic units
- 10 within this Commonwealth, which may be used to illustrate the
- 11 locations of legislative district boundaries proposed in plans
- 12 <u>drawn in accordance with subsection (d).</u>
- 13 (3) As soon as possible after January 1 of each year ending
- 14 in one, the bureau shall obtain from the United States Census
- 15 Bureau the population data needed for legislative districting
- 16 that the Census Bureau is required to provide the Commonwealth
- 17 under 13 U.S.C. § 141 (relating to population and other census
- 18 information) and shall use that data to assign a population
- 19 figure based upon census data to each geographic or political
- 20 unit described pursuant to paragraph (2)(i). Upon completing
- 21 that task, the bureau shall begin the preparation of
- 22 congressional and legislative districting plans as required by
- 23 subsection (c).
- 24 (c) (1) Not later than April 1 of each year ending in one,
- 25 the bureau shall deliver to the Secretary of the Senate and the
- 26 Chief Clerk of the House of Representatives identical bills
- 27 embodying a plan of legislative and congressional districting
- 28 prepared in accordance with subsection (d). It is the intent of
- 29 this section that the General Assembly shall bring the bill to a
- 30 vote in either the Senate or the House of Representatives

- 1 expeditiously, but not less than seven days after the report of
- 2 the commission required by subsection (f) is received and made
- 3 available to the members of the General Assembly, under a
- 4 <u>procedure or rule permitting no amendments except those of a</u>
- 5 purely corrective nature. It is further the intent of this
- 6 section that, if the bill is approved by the first House in
- 7 which it is considered, it shall expeditiously be brought to a
- 8 vote in the second House under a similar procedure or rule.
- 9 (2) If the bill embodying the plan submitted by the bureau
- 10 under paragraph (1) fails to be approved by a constitutional
- 11 majority in either the Senate or the House of Representatives,
- 12 the Secretary of the Senate or the Chief Clerk of the House of
- 13 Representatives, as the case may be, shall at once transmit to
- 14 the bureau information which the Senate or House of
- 15 Representatives may direct regarding reasons why the plan was
- 16 <u>not approved. The bureau shall prepare a bill embodying a second</u>
- 17 plan of legislative and congressional districting prepared in
- 18 accordance with subsection (d), taking into account the reasons
- 19 cited by the Senate or House of Representatives for its failure
- 20 to approve the plan insofar as it is possible to do so within
- 21 the requirements of subsection (d). If a second plan is required
- 22 under this subsection, the bill embodying it shall be delivered
- 23 to the Secretary of the Senate and the Chief Clerk of the House
- 24 of Representatives not later than May 1 of the year ending in
- 25 one or 14 days after the date of the vote by which the Senate or
- 26 the House of Representatives failed to approve the bill
- 27 <u>submitted under paragraph (1), whichever date is later. It is</u>
- 28 the intent of this section that, if it is necessary to submit a
- 29 bill under this subsection, the bill be brought to a vote not
- 30 less than seven days after the bill is printed and made

- 1 <u>available to the members of the General Assembly, in the same</u>
- 2 manner as prescribed for the bill required under paragraph (1).
- 3 (3) If the bill embodying the plan submitted by the bureau
- 4 <u>under paragraph (2) fails to be approved by a constitutional</u>
- 5 majority in either the Senate or the House of Representatives,
- 6 the same procedure as prescribed by paragraph (2) shall be
- 7 <u>followed. If a third plan is required under this subsection, the</u>
- 8 <u>bill embodying it shall be delivered to the Secretary of the</u>
- 9 Senate and the Chief Clerk of the House of Representatives not
- 10 later than June 1 of the year ending in one or 14 days after the
- 11 date of the vote by which the Senate or the House of
- 12 Representatives failed to approve the bill submitted under
- 13 paragraph (2), whichever date is later. It is the intent of this
- 14 <u>section that if it is necessary to submit a bill under this</u>
- 15 subsection, the bill be brought to a vote within the same time
- 16 period after its delivery to the Secretary of the Senate and the
- 17 Chief Clerk of the House of Representatives as is prescribed for
- 18 the bill submitted under paragraph (2), but shall be subject to
- 19 amendment in the same manner as other bills.
- 20 (4) Notwithstanding paragraphs (1), (2) and (3):
- 21 (i) If population data from the Federal census which is
- 22 sufficient to permit preparation of a congressional districting
- 23 plan becomes available at an earlier time than the population
- 24 data needed to permit preparation of a legislative districting
- 25 plan in accordance with subsection (d), the bureau shall so
- 26 inform the presiding officers of the Senate and the House of
- 27 Representatives. If the presiding officers so direct, the bureau
- 28 shall prepare a separate bill establishing congressional
- 29 districts and submit it separately from the bill establishing
- 30 legislative districts. It is the intent of this section that the

- 1 General Assembly proceed to consider the congressional
- 2 districting bill in substantially the manner prescribed by
- 3 paragraphs (1), (2) and (3).
- 4 (ii) If the population data for legislative districting
- 5 which the United States Census Bureau is required to provide
- 6 this Commonwealth under 13 U.S.C. § 141 is not available to the
- 7 <u>Legislative and Congressional Reapportionment Bureau on or</u>
- 8 before February 1 of the year ending in one, the dates set forth
- 9 <u>in this section shall be extended by a number of days equal to</u>
- 10 the number of days after February 1 of the year ending in one
- 11 that the Federal census population data for legislative
- 12 <u>districting becomes available.</u>
- 13 (d) (1) Legislative and congressional districts shall be
- 14 <u>established on the basis of population.</u>
- (i) Senatorial and representative districts, respectively,
- 16 shall each have a population as nearly equal as practicable to
- 17 the ideal population for such districts, determined by dividing
- 18 the number of districts to be established into the population of
- 19 this Commonwealth reported in the Federal decennial census.
- 20 Senatorial districts and representative districts shall not vary
- 21 in population from the respective ideal district populations
- 22 except as necessary to comply with one of the other standards
- 23 <u>enumerated in this section. In no case shall the quotient,</u>
- 24 obtained by dividing the total of the absolute values of the
- 25 deviations of all district populations from the applicable ideal
- 26 district population by the number of districts established,
- 27 <u>exceed 2.5% of the applicable ideal district population. No</u>
- 28 senatorial district shall have a population which exceeds that
- 29 of any other senatorial district by more than 5%, and no
- 30 representative district shall have a population which exceeds

- 1 that of any other representative district by more than 5%.
- 2 (ii) Congressional districts shall each have a population as
- 3 nearly equal as practicable to the ideal district population,
- 4 <u>derived as prescribed in subparagraph (i). No congressional</u>
- 5 district shall have a population which varies by more than 2.5%
- 6 from the applicable ideal district population.
- 7 (iii) If a challenge is filed with the Supreme Court
- 8 <u>alleging excessive population variance among districts</u>
- 9 <u>established in a plan adopted by the General Assembly, the</u>
- 10 General Assembly has the burden of justifying any variance in
- 11 excess of 2.5% between the population of a district and the
- 12 <u>applicable ideal district population.</u>
- 13 (2) To the extent consistent with paragraph (1), district
- 14 boundaries shall coincide with the boundaries of political
- 15 <u>subdivisions of this Commonwealth. The number of counties and</u>
- 16 <u>cities divided among more than one district shall be as small as</u>
- 17 possible. When there is a choice between dividing local
- 18 political subdivisions, the more populous subdivisions shall be
- 19 <u>divided before the less populous, but this statement does not</u>
- 20 apply to a legislative district boundary drawn along a county
- 21 line which passes through a city that lies in more than one
- 22 county.
- 23 (3) Districts shall be composed of convenient contiquous
- 24 territory. Areas which meet only at the points of adjoining
- 25 corners are not contiguous.
- 26 (4) It is preferable that districts be compact in form, but
- 27 the standards established by paragraphs (1), (2) and (3) take
- 28 precedence over compactness where a conflict arises between
- 29 <u>compactness and these standards. In general, compact districts</u>
- 30 are those which are square, rectangular or hexagonal in shape to

- 1 the extent permitted by natural or political boundaries.
- 2 (5) Districts should represent communities of interest as
- 3 reflected by common economic patterns of production and
- 4 consumption, school district boundaries, cultural activities,
- 5 <u>self-identification</u>, <u>media coverage and other relevant</u>
- 6 <u>demographic information</u>.
- 7 (6) However, no district shall be drawn for the purpose of
- 8 <u>favoring a political party, incumbent legislator or member of</u>
- 9 Congress or other person or group. In establishing districts, no
- 10 use shall be made of any of the following data:
- 11 (i) Addresses of incumbent legislators or members of
- 12 <u>Congress</u>.
- 13 <u>(ii) Political affiliations of registered voters.</u>
- 14 <u>(iii) Previous election results.</u>
- 15 (7) Each bill embodying a plan drawn under this section
- 16 shall provide that any vacancy in the General Assembly which is
- 17 filled in the year ending in one, occurring at a time which
- 18 makes it necessary to fill the vacancy at a special election
- 19 held under section 629 of the act of June 3, 1937 (P.L.1333,
- 20 No.320), known as the Pennsylvania Election Code, shall be
- 21 filled from the same district which elected the senator or
- 22 <u>representative whose seat is vacant.</u>
- 23 (8) Each bill embodying a plan drawn under this section
- 24 shall include provisions for election of senators to the General
- 25 Assemblies which take office in the years ending in three and
- 26 five, which shall be in conformity with section 16 of this
- 27 <u>article</u>.
- 28 (e) (1) Not later than February 15 of each year ending in
- 29 one, a five-member temporary redistricting advisory commission
- 30 shall be established as provided by this section. The

- 1 commission's only functions shall be those prescribed by
- 2 subsection (f).
- 3 (i) Each of the four selecting authorities shall certify to
- 4 the chief election officer his appointment of a person to serve
- 5 on the commission. The certifications may be made at any time
- 6 after the four selecting authorities have been selected for the
- 7 General Assembly to take office in the year ending in one, even
- 8 though the terms of office of the selecting authorities have not
- 9 <u>actually begun.</u>
- 10 (ii) Within 30 days after the four selecting authorities
- 11 have certified their respective appointments to the commission,
- 12 but in no event later than February 15 of the year ending in
- 13 one, the four commission members so appointed shall select, by a
- 14 vote of at least three members, and certify to the chief
- 15 election officer the fifth commission member who shall serve as
- 16 <u>chairperson</u>.
- 17 (iii) A vacancy on the commission shall be filled by the
- 18 initial selecting authority within 15 days after the vacancy
- 19 occurs.
- 20 (iv) Members of the commission shall receive per diem travel
- 21 expenses and reimbursement for other necessary expenses incurred
- 22 in performing their duties under this section.
- 23 (2) No person shall be appointed to the commission who:
- 24 (i) Is not an eligible elector of this Commonwealth at the
- 25 time of selection.
- 26 (ii) Holds partisan public office or political party office.
- 27 <u>(iii) Is a relative of or is employed by a member of the</u>
- 28 General Assembly or of Congress or is employed directly by the
- 29 General Assembly or by Congress.
- 30 (f) The functions of the commission shall be as follows:

- 1 (1) If, in preparation of plans as required by this section,
- 2 the bureau is confronted with the necessity to make any decision
- 3 for which no clearly applicable guideline is provided by
- 4 <u>subsection (d), the bureau may submit a written request for</u>
- 5 direction to the commission.
- 6 (2) Prior to delivering any plan and the bill embodying that
- 7 plan to the Secretary of the Senate and the Chief Clerk of the
- 8 House of Representatives in accordance with subsection (c), the
- 9 bureau shall provide to persons outside the bureau staff only
- 10 such information regarding the plan as may be required by
- 11 policies agreed upon by the commission. This paragraph does not
- 12 apply to population data furnished to the bureau by the United
- 13 <u>States Census Bureau.</u>
- 14 (3) Upon each delivery by the bureau to the General Assembly
- 15 of a bill embodying a plan, pursuant to subsection (c), the
- 16 commission shall at the earliest feasible time make available to
- 17 the public the following information:
- 18 (i) Copies of the bill delivered by the bureau to the
- 19 General Assembly.
- 20 (ii) Maps illustrating the plan.
- 21 (iii) A summary of the standards prescribed by subsection
- 22 (d) for development of the plan.
- 23 (iv) A statement of the population of each district included
- 24 in the plan and the relative deviation of each district
- 25 population from the ideal district population.
- 26 (4) Upon the delivery by the bureau to the General Assembly
- 27 of a bill embodying an initial plan, as required by subsection
- 28 (c)(1), the commission shall:
- 29 (i) As expeditiously as reasonably possible, schedule and
- 30 conduct at least three public hearings, in different geographic

- 1 regions of this Commonwealth, on the plan embodied in the bill
- 2 <u>delivered by the bureau to the General Assembly.</u>
- 3 (ii) Following the hearings, promptly prepare and submit to
- 4 the Secretary of the Senate and the Chief Clerk of the House of
- 5 Representatives a report summarizing information and testimony
- 6 received by the commission in the course of the hearings. The
- 7 <u>commission's report shall include any comments and conclusions</u>
- 8 which its members deem appropriate on the information and
- 9 testimony received at the hearings or otherwise presented to the
- 10 commission.
- [(f)] (g) Any district which does not include the residence
- 12 from which a member of the Senate was elected whether or not
- 13 scheduled for election at the next general election shall elect
- 14 a Senator at such election.
- 15 [(g) The General Assembly shall appropriate sufficient funds
- 16 for the compensation and expenses of members and staff appointed
- 17 by the commission, and other necessary expenses. The members of
- 18 the commission shall be entitled to such compensation for their
- 19 services as the General Assembly from time to time shall
- 20 determine, but no part thereof shall be paid until a preliminary
- 21 plan is filed. If a preliminary plan is filed but the commission
- 22 fails to file a revised or final plan within the time
- 23 prescribed, the commission members shall forfeit all right to
- 24 compensation not paid.
- 25 (h) If a preliminary, revised or final reapportionment plan
- 26 is not filed by the commission within the time prescribed by
- 27 this section, unless the time be extended by the Supreme Court
- 28 for cause shown, the Supreme Court shall immediately proceed on
- 29 its own motion to reapportion the Commonwealth.
- 30 (i) Any reapportionment plan filed by the commission, or

- 1 ordered or prepared by the Supreme Court upon the failure of the
- 2 commission to act, shall be published by the elections officer
- 3 once in at least one newspaper of general circulation in each
- 4 senatorial and representative district. The publication shall
- 5 contain a map of the Commonwealth showing the complete
- 6 reapportionment of the General Assembly by districts, and a map
- 7 showing the reapportionment districts in the area normally
- 8 served by the newspaper in which the publication is made. The
- 9 publication shall also state the population of the senatorial
- 10 and representative districts having the smallest and largest
- 11 population and the percentage variation of such districts from
- 12 the average population for senatorial and representative
- 13 districts.]
- 14 (h) All positions in the bureau shall be deemed to be
- 15 included in the list of positions set forth in section 3(d) of
- 16 the act of August 5, 1941 (P.L.752, No.286), known as the Civil
- 17 Service Act, and the provisions and benefits of the act shall be
- 18 applicable to the employees of and positions in the bureau.
- 19 (i) The bureau shall expire and its responsibilities shall
- 20 terminate not later than November 1 of each year ending in one
- 21 and shall be reconstituted on November 1 in the year of the next
- 22 Federal decennial census.
- 23 (j) The following words and phrases when used in this
- 24 section shall have the meanings given to them in this subsection
- 25 unless the context clearly indicates otherwise:
- 26 "Bureau." The Legislative and Congressional Reapportionment
- 27 Bureau.
- 28 <u>"Chief election officer." The Secretary of the Commonwealth</u>
- 29 <u>or a designee.</u>
- 30 "Commission." The temporary redistricting advisory

- 1 commission established under this section.
- 2 <u>"Federal census."</u> The decennial census required by Federal
- 3 law to be conducted by the United States Census Bureau in every
- 4 <u>year ending in zero.</u>
- 5 <u>"Four selecting authorities."</u>
- 6 (1) The Majority Leader of the Senate.
- 7 (2) The Minority Leader of the Senate.
- 8 (3) The Majority Leader of the House of Representatives.
- 9 (4) The Minority Leader of the House of Representatives.
- 10 <u>"Partisan public office."</u>
- 11 (1) An elective or appointive office in the executive or
- 12 <u>legislative branch or in an independent establishment of the</u>
- 13 <u>Federal Government.</u>
- 14 (2) An elective office in the executive or legislative
- 15 branch of the government of this Commonwealth or an office which
- 16 <u>is filled by appointment.</u>
- 17 (3) An office of a county, city or other political
- 18 subdivision of this Commonwealth which is filled by an election
- 19 process involving nomination and election of candidates on a
- 20 partisan basis.
- 21 "Plan." A plan for legislative and congressional
- 22 reapportionment drawn under the requirements of this section.
- 23 "Political party office." An elective office in the national
- 24 or State organization of a political party.
- 25 "Relative." An individual who is related to the person in
- 26 question as father, mother, son, daughter, brother, sister,
- 27 <u>uncle, aunt, first cousin, nephew, niece, husband, wife,</u>
- 28 grandfather, grandmother, father-in-law, mother-in-law, son-in-
- 29 <u>law, daughter-in-law, brother-in-law, sister-in-law, stepfather,</u>
- 30 stepmother, stepson, stepdaughter, stepbrother, stepsister, half

- 1 <u>brother or half sister.</u>
- 2 Section 2. (a) Upon the first passage by the General
- 3 Assembly of this proposed constitutional amendment, the
- 4 Secretary of the Commonwealth shall proceed immediately to
- 5 comply with the advertising requirements of section 1 of Article
- 6 XI of the Constitution of Pennsylvania and shall transmit the
- 7 required advertisements to two newspapers in every county in
- 8 which such newspapers are published in sufficient time after
- 9 passage of this proposed constitutional amendment.
- 10 (b) Upon the second passage by the General Assembly of this
- 11 proposed constitutional amendment, the Secretary of the
- 12 Commonwealth shall proceed immediately to comply with the
- 13 advertising requirements of section 1 of Article XI of the
- 14 Constitution of Pennsylvania and shall transmit the required
- 15 advertisements to two newspapers in every county in which such
- 16 newspapers are published in sufficient time after passage of
- 17 this proposed constitutional amendment. The Secretary of the
- 18 Commonwealth shall submit this proposed constitutional amendment
- 19 to the qualified electors of this Commonwealth at the first
- 20 primary, general or municipal election which meets the
- 21 requirements of and is in conformance with section 1 of Article
- 22 XI of the Constitution of Pennsylvania and which occurs at least
- 23 three months after the proposed constitutional amendment is
- 24 passed by the General Assembly.
