AN ACT

- Providing for open contracting by the Commonwealth and its political subdivisions and their agencies and authorities.
- 3 The General Assembly of the Commonwealth of Pennsylvania
- 4 hereby enacts as follows:
- 5 Section 1. Short title.
- 6 This act shall be known and may be cited as the Public Works
- 7 Open Contracting Act.
- 8 Section 2. Definitions.
- 9 The following words and phrases when used in this act shall
- 10 have the meanings given to them in this section unless the
- 11 context clearly indicates otherwise:
- 12 "Public body." The Commonwealth or any of its political
- 13 subdivisions, or an agency or authority of either.
- 14 "Public works." Construction, reconstruction, demolition,
- 15 alteration or repair work, other than routine maintenance work,

- 1 contracted for by a public body.
- 2 "Responsible bidder." A person, partnership or corporation <--
- 3 that has the capability in all respects to fully perform the
- 4 contract requirements and has the integrity and reliability that
- 5 will assure good faith performance.
- 6 Section 3. Prohibited practices.
- 7 Contract specifications issued by a public body soliciting
- 8 bids OR PROPOSALS on a public works project may not include any <--

- 9 of the following:
- 10 (1) A requirement that a successful bidder OR A
- 11 SUCCESSFUL OFFEROR or any of its subcontractors utilize
- 12 workers:
- 13 (i) represented by a designated labor organization;
- 14 or
- 15 (ii) referred by a designated labor organization.
- 16 (2) A requirement that a successful bidder's existing
- work force or any of its subcontractors' work forces
- affiliate with or pay dues to a labor organization.
- 19 (3) A requirement that a successful bidder OR A <-
- 20 SUCCESSFUL OFFEROR or any of its subcontractors recognize a
- 21 labor organization as the exclusive representative of any of
- its employees on the public works project.
- 23 Section 4. Discrimination prohibited.
- No public body may consider or use as a criterion in its
- 25 selection process the union or nonunion status of a bidder's OR <--
- 26 OFFEROR'S work force.
- 27 Section 5. Enforcement.
- 28 (a) General rule. -- A party who is aggrieved by an act
- 29 committed by a public body in violation of section 3 or 4 may
- 30 file an action in a court of competent jurisdiction to enjoin

- 1 the act.
- 2 (b) Damages and attorney fees.--A court of competent
- 3 jurisdiction may award damages and reasonable attorney fees to
- 4 an aggrieved party that is successful in an action filed under
- 5 subsection (a).
- 6 SECTION 6. APPLICABILITY.
