## AN ACT

- Amending the act of July 6, 1989 (P.L.169, No.32), entitled, as amended, "An act providing for the regulation of storage 1

- 8 The General Assembly of the Commonwealth of Pennsylvania
- hereby enacts as follows:
- 10 Section 1. Section 703(a)(1) of the act of July 6, 1989
- 11 (P.L.169, No.32), known as the Storage Tank and Spill Prevention
- 12 Act, amended January 30, 1998 (P.L.46, No.13), is amended to
- 13 read:
- 14 Section 703. Underground Storage Tank Indemnification Board.
- 15 Establishment of board, appointment and terms. -- There is
- hereby created the Underground Storage Tank Indemnification 16
- 17 Board which shall consist of ten members. The Insurance
- 18 Commissioner and the Secretary of the Department of
- 19 Environmental Protection shall be ex officio members. Eight
- 20 members shall be appointed by the Governor, as follows:

1	(1) Six members who shall be persons with particular
2	expertise in the management of underground storage tanks.
3	Three of these members shall be appointed for terms of four
4	years and three shall be appointed for a term of three years.
5	The Governor shall appoint the members, one each from a list
6	of nominees provided by each of the following:
7	(i) The Associated Petroleum Industries of
8	Pennsylvania.
9	(ii) The Pennsylvania Petroleum Association.
10	(iii) The Service Station Dealers and Automotive
11	Repair Association of Pennsylvania and Delaware and the
12	Petroleum Retailers and Auto Repair Association, Inc.
13	(iv) [The Middle Atlantic Truck Stop Operators] $\underline{A}$
14	Statewide organization representing fuel retailers and
15	<pre>food merchants.</pre>
16	(v) The Pennsylvania Farm Bureau, Pennsylvania State
17	Grange and Pennsylvania Farmers Union.
18	(vi) The Tank Installers of Pennsylvania.

20 Section 2. This act shall take effect in 60 days.
