6	Section 1. Section 1901(c) and (d)(2) of Title 75 of the
7	Pennsylvania Consolidated Statutes are amended and subsection
8	(b) is amended by adding paragraphs to read:

11	(b) Title and registration feesNo fee shall be charged
12	for titling or registration of any of the following:

14	(6) Vehicles registered to a veteran who lost a limb or
15	eye or who became partially paralyzed while serving in the
16	armed forces of the United States.
17	(7) Vehicles registered to a person who, as a member of

1	the armed forces of the United States, was captured by the
2	enemy during World War II, the Korean Emergency, the Vietnam
3	Conflict or in a future armed conflict for which the
4	Department of Defense authorizes a campaign medal.
5	(8) Vehicles registered to a person who has been awarded
6	the Congressional Medal of Honor or the Purple Heart.

8	(c) Processing fee in lieu of registration feeNo
9	registration fee shall be charged for vehicles registered by any
10	of the following but the department shall charge a fee of \$10 to
11	cover the costs of processing for issuing or renewing the
12	registration:

14	(2) Humane society.
15	(3) Nonprofit youth center.
16	(4) American Red Cross.
17	(5) Church.
18	(6) Girl Scouts of America.

Unless the retired person is physically or mentally incapable of driving the vehicle, the retired person shall be the principal driver of the vehicle but may from time to time authorize another person to drive the vehicle in his or her stead.

7 [(17) Any veteran who lost a limb or eye or who became 8 partially paralyzed while serving in the armed forces of the 9 United States.

10 (18) A person who, as a member of the armed forces of 11 the United States, was captured by the enemy during World War 12 I, World War II, the Korean Emergency, the Vietnam Conflict 13 or in a future armed conflict for which the Department of 14 Defense authorizes a campaign medal.

15 (19) Any person who has been awarded the Congressional16 Medal of Honor.]

17 (20) Nonprofit organizations which care for or otherwise18 provide services for the elderly or the infirm.
