15	Section 6. Exemptions from registration.
16	(a) General ruleThe following charitable organizations
17	shall be exempt from the registration requirements of this act:

19	(3) A local post, camp, chapter or similarly designated
20	element or a county unit of such elements of:
21	(i) any veterans' organization chartered under

1 Federal law and any service foundation recognized in the bylaws of such organization; 2 a bona fide organization of volunteer firemen; 3 (ii) (iii) a bona fide ambulance association; 4 5 (iv) a bona fide rescue squad association; or (v) a bona fide auxiliary or affiliate of any 6 7 organization or association under subparagraph (i), (ii), 8 (iii) or (iv); 9 provided that all fundraising activities of an organization 10 or association under subparagraph (i), (ii), (iii), (iv) or (v) are carried on by volunteers, members or an auxiliary or 11 12 affiliate thereof, and those volunteers, members or 13 affiliates receive no compensation directly or indirectly for 14 the fundraising activities. 15 For the purpose of this paragraph, the term "fundraising_ activities" does not include any of the following: 16 17 (i) Copying and printing camera-ready materials. 18 (ii) Folding solicitations and inserting 19 solicitations in envelopes. 20 (iii) Addressing envelopes, including printing and 21 affixing address labels. 22 (iv) Mailing or delivering envelopes to a post 23 office for mailing. 24 (v) Using computer software to process mail and apply 25 postal discounts or bar codes. * * * 26 27 Section 2. This act shall take effect immediately.
