AN ACT

- Amending the act of April 9, 1929 (P.L.177, No.175), entitled, as amended, "An act providing for and reorganizing the 2 conduct of the executive and administrative work of the 3 Commonwealth by the Executive Department thereof and the administrative departments, boards, commissions, and officers thereof, including the boards of trustees of State Normal Schools, or Teachers Colleges; abolishing, creating, 7 reorganizing or authorizing the reorganization of certain administrative departments, boards, and commissions; defining 8 9 the powers and duties of the Governor and other executive and 10 administrative officers, and of the several administrative 11 departments, boards, commissions, and officers; fixing the 12 salaries of the Governor, Lieutenant Governor, and certain 13 other executive and administrative officers; providing for 14 15 the appointment of certain administrative officers, and of all deputies and other assistants and employes in certain 16 departments, boards, and commissions; providing for judicial 17 18 administration; and prescribing the manner in which the 19 number and compensation of the deputies and all other assistants and employes of certain departments, boards and 20 commissions shall be determined," in Commonwealth budget 21 procedures, further providing for transmission of budget 22 23 information to the General Assembly.
- 24 The General Assembly of the Commonwealth of Pennsylvania
- 25 hereby enacts as follows:
- 26 Section 1. Section 619 of the act of April 9, 1929 (P.L.177,

- 1 No.175), known as The Administrative Code of 1929, is amended by
- 2 adding a subsection to read:
- 3 Section 619. Transmission of Budget Information to the
- 4 General Assembly. --* * *
- 5 (a.1) (1) After December 1 and no later than the date of
- 6 the Governor's briefing under subsection (a), the Secretary of
- 7 the Budget shall evaluate the official REVENUE estimate for the <--
- 8 <u>fiscal year in comparison to year-to-date revenue collections</u>
- 9 and updated projections of collections for the remainder of the
- 10 <u>fiscal year and shall project the difference between the</u>
- 11 official estimate REVENUE ESTIMATE FOR THE FISCAL YEAR and the <--
- 12 <u>year-to-date revenue collection and COLLECTIONS PLUS updated</u>
- 13 projections of collections for the remainder of the fiscal year.
- 14 The Secretary of the Budget shall provide documentation of the
- 15 projection under this paragraph to the chairperson and minority
- 16 <u>chairperson of the Appropriations Committee of the Senate and</u>
- 17 the chairperson and minority chairperson of the Appropriations
- 18 Committee of the House of Representatives.
- 19 (2) If the Secretary of the Budget projects that the UPDATED <--
- 20 PROJECTION OF actual revenue collections plus any unappropriated_<--
- 21 surplus for the fiscal year will be less than the official
- 22 <u>estimate REVENUE ESTIMATE FOR THE FISCAL YEAR, the Secretary of</u> <--
- 23 the Budget shall disapprove or reduce amounts under section 615
- 24 from the departments, boards and commissions to which section
- 25 615 applies in an amount equal to the projected difference.
- 26 (3) After the revenue conference under section 608-B, the
- 27 Secretary of the Budget shall revise the projection of the
- 28 <u>difference under clause (1) and shall ensure that the amounts</u>
- 29 disapproved or reduced under clause (2) are no less than the
- 30 <u>revised estimate of the difference under clause (1), at least</u>

- 1 once per month until the end of the fiscal year.

- 3 Section 2. This act shall take effect July 1, 2018, or
- 4 immediately, whichever is later.
