7	Section 1. Section 1105(b)(5) and (c) of Title 65 of the
8	Pennsylvania Consolidated Statutes are amended to read:
9	§ 1105. Statement of financial interests.

11	(b) Required informationThe statement shall include the
12	following information for the prior calendar year with regard to
13	the person required to file the statement:
14	* * *
15	(5) The following shall apply:
16	(i) The [name and address] <u>amount and source</u> of any
17	direct or indirect source of income totaling in the

1	aggregate \$1,300 or more. The source shall be identified
2	by its name and address.
3	(ii) The amount of the income shall be reported by
4	indicating one of the following ranges for the amount:
5	(A) between \$1,000 and \$74,999;
6	<u>(B) between \$75,000 and \$99,999;</u>
7	(C) between \$100,000 and \$149,999;
8	(D) between \$150,000 and \$249,999;
9	<u>(E) between \$250,000 and \$499,999;</u>
10	<u>(F) between \$500,000 and \$749,999;</u>
11	<u>(G) between \$750,000 and \$999,999; or</u>
12	<u>(H)</u> \$1,000,000 or more.
13	(iii) Income received in the form of a security may
14	be reported by indicating the number of shares and the
15	name and address of the issuer. For purposes of this
16	paragraph, "security" shall have the same meaning given
17	to it in 13 Pa.C.S. § 8102 (relating to definitions).
18	[However, this] <u>(iv) This</u> provision shall not be
19	construed to require the divulgence of confidential
20	information protected by statute or existing professional
21	codes of ethics or common law privileges.

23	(c) Reporting amountsExcept where an amount is required
24	to be reported pursuant to subsection (b) (5) , (6) and (7), the
25	statement of financial interests need not include specific
26	amounts for the items required to be listed.

28	Section 2. This act shall take effect January 1, 2017.
