Amending Title 53 (Municipalities Generally) of the Pennsylvania <--Consolidated Statutes, in employees, further providing for 2 definitions and for automatic certification. 3 AMENDING TITLES 42 (JUDICIARY AND JUDICIAL PROCEDURE) AND 53 <--(MUNICIPALITIES GENERALLY) OF THE PENNSYLVANIA CONSOLIDATED 5 STATUTES, IN RECORDINGS BY LAW ENFORCEMENT OFFICERS, FURTHER 6 PROVIDING FOR DEFINITIONS; IN EMPLOYEES, FURTHER PROVIDING FOR DEFINITIONS; AND PROVIDING FOR AUTOMATIC CERTIFICATION BY 8 THE MUNICIPAL POLICE OFFICERS' EDUCATION AND TRAINING 9 COMMISSION. 10 11 The General Assembly of the Commonwealth of Pennsylvania 12 hereby enacts as follows: 13 Section 1. - 30 under the definition of "criminal justice agency" in 18 Pa.C.S.

- 4 "Police department." Any of the following:
- 5 (1) A public agency of a political subdivision having
- 6 general police powers and charged with making arrests in

- 8 laws. This paragraph includes the sheriff's office in a
- 9 county of the second class.
- 10 (2) A campus police or university police department, as
- 11 used in section 2416 of the act of April 9, 1929 (P.L.177,
- 12 No.175), known as The Administrative Code of 1929, certified
- by the Office of Attorney General as a criminal justice
- agency under the definition of "criminal justice agency" in
- 15 18 Pa.C.S. § 9102 (relating to definitions). [This paragraph
- does not include a campus police or university police
- 17 department of the State System of Higher Education and its
- member institutions.]
- 19 (3) A railroad or street railway police department
- formed with officers commissioned under 22 Pa.C.S. Ch. 33
- 21 (relating to railroad and street railway police) or any prior
- 22 statute providing for such commissioning.
- 23 (4) The Capitol Police.
- 24 (5) The Harrisburg International Airport Police.
- 25 (6) An airport authority police department.
- 26 (7) A county park police force under section 2511(b) of

- 29 "Police officer." Any of the following:
- 30 (1) A full-time or part-time employee assigned to

- 1 criminal or traffic law enforcement duties of any of the
- 2 following:
- 3 (i) A police department of a county, city, borough,
- 4 town or township.
- 5 (ii) Any railroad or street railway police.
- 6 (iii) Any campus or university police department,
- 7 <u>including the State System of Higher Education and its</u>
- 8 <u>member institutions</u>.
- 9 (iv) The Capitol Police.
- 10 (v) The Harrisburg International Airport Police.
- 11 (vi) An airport authority police department.
- 12 (2) A deputy sheriff of a county of the second class.

- 15 authority.

- "University." A university which has a campus police

- 26 in 18 Pa.C.S. § 9102 (relating to definitions). [The term does

2 (b) Campus or university police.

(1) Any campus or university police officer who, as of August 27, 1993, has successfully completed a basic training course similar to that required under this subchapter shall, after review by the commission, be certified as having met the basic training requirements of this subchapter. Any campus or university police officer who, as of August 27, 1993, has not successfully completed a basic training course similar to that required under this subchapter which qualifies the police officer for certification under this subsection shall be able to perform the duties of a campus or university police officer until certified by the commission, but no later than August 29, 1994.

(2) Campus police as defined in section 2001—A(20) of the act of March 10, 1949 (P.L.30, No.14), known as the Public School Code of 1949, who have successfully completed the basic training course from the commission before or on the effective date of this paragraph shall be automatically certified by the commission.

- 26 PSYCHOLOGICAL EVALUATION FOR EMPLOYMENT AS A LAW ENFORCEMENT
- 27 OFFICER BEFORE THE EFFECTIVE DATE OF THIS SECTION SHALL BE
- 28 AUTOMATICALLY CERTIFIED BY THE MUNICIPAL POLICE OFFICERS'
- 29 EDUCATION AND TRAINING COMMISSION.
- 30 Section $\frac{3}{4}$. This act shall take effect immediately.
