AN ACT

- 1 Amending Title 51 (Military Affairs) of the Pennsylvania
- 2 Consolidated Statutes, in professional and occupational
- licenses, further providing for definitions and providing for
- 4 military medical personnel pilot program.
- 5 The General Assembly of the Commonwealth of Pennsylvania
- 6 hereby enacts as follows:
- 7 Section 1. Section 7501 of Title 51 of the Pennsylvania
- 8 Consolidated Statutes is amended by adding definitions to read:
- 9 § 7501. Definitions.
- 10 The following words and phrases when used in this chapter
- 11 shall have the meanings given to them in this section unless the
- 12 context clearly indicates otherwise:
- 13 "Corpsman." An individual who has served as military medical
- 14 personnel in the United States Navy or Coast Guard and who was
- 15 discharged or released from such service under conditions other
- 16 than dishonorable.
- 17 "Medic." An individual who has served in the United States

- 1 Army as military medical personnel and who was discharged or
- 2 released from such service under conditions other than
- 3 dishonorable.
- 4 "Medical technician." An individual who has served in the
- 5 <u>United States Air Force as military medical personnel and who</u>
- 6 was discharged or released from such service under conditions
- 7 other than dishonorable.

- 9 Section 2. Title 51 is amended by adding a section to read:
- 10 § 7505. Military medical personnel pilot program.
- 11 (a) Establishment. -- The Department of Health and the
- 12 <u>Department of State in consultation with the department shall</u>
- 13 <u>establish a pilot program in which military medical personnel</u>
- 14 may practice and perform certain delegated duties that
- 15 constitute the practice of medicine under the supervision of a
- 16 physician or podiatrist who holds an active, unrestricted
- 17 license issued by the Commonwealth. The duties shall reflect the
- 18 level of training and experience of the military medical
- 19 personnel. The supervising physician or podiatrist shall retain
- 20 <u>responsibility for the care of the patient.</u>
- 21 (b) Participation. -- A licensed physician, podiatrist,
- 22 hospital or medical facility that is supervised by one or more
- 23 physicians or podiatrists may participate in the pilot program.
- 24 (c) Requirements. -- The departments listed in subsection (a)
- 25 shall establish general requirements for participating military
- 26 medical personnel, licensees and employers.
- 27 Section 3. This act shall take effect in 60 days.
