- 10 (b.1) Free identification card for a homeless individual .--
- 11 The department shall issue an identification card at no cost to
- 12 any person ten years of age or older who is homeless and who has
- made application therefor in such manner as the department shall 13
- 14 prescribe. The department may require additional documentation
- 15 to verify the homeless status of an applicant. For the purposes
- of this subsection, the term "homeless" shall have the meaning 16
- given to it in section 103 of the McKinney-Vento Homeless 17
- Assistance Act (Public Law 100-77, 42 U.S.C. § 11302). 18

- 1 (b.2) Free identification card for an individual in
- 2 poverty. -- The department shall issue an identification card at
- 3 <u>no cost to any person ten years of age or older who is a member</u>
- 4 of a household in poverty and has made application thereof in
- 5 <u>such manner as the department shall prescribe. The department</u>
- 6 may require additional documentation to verify an applicant's
- 7 poverty status. For the purposes of this subsection, the term
- 8 "poverty" shall mean a household with total income at or below
- 9 the poverty guideline, adjusted for household size, as published
- 10 annually by the United States Department of Health and Human
- 11 <u>Services in the Federal Register.</u>
- 12 (b.3) Free identification card for a disabled individual. --
- 13 The department shall issue an identification card at no cost to
- 14 any person ten years of age or older who is considered disabled
- 15 <u>as described in subsection 1338(a) (relating to person with</u>
- 16 <u>disability plate and placard</u>) and has made application thereof
- 17 in such manner as the department shall prescribe. The department
- 18 may require a health care provider's statement as described in
- 19 section 1338(c) to verify an applicant's disabled status.

- 21 Section 2. This act shall take effect in 60 days.
