9	The General Assembly of the Commonwealth of Pennsylvania
10	hereby enacts as follows:
11	Section 1. The act of November 6, 1987 (P.L.381, No.79),
12	known as the Older Adults Protective Services Act, is amended by
13	adding a chapter to read:
14	CHAPTER 6
15	FINANCIAL INSTITUTIONS AND FIDUCIARIES
16	Section 601. Definitions.
17	The following words and phrases when used in this chapter
18	shall have the meanings given to them in this section unless the
19	<pre>context clearly indicates otherwise:</pre>
20	"A person reasonably associated with the older adult." The

- 1 term includes:
- 2 (1) an authorized contact provided by an older adult to
- 3 a financial institution;
- 4 (2) a fiduciary authorized to manage some or all of the
- 5 financial affairs of the older adult;
- 6 (3) a co-owner, additional authorized signatory or
- 5 beneficiary on an older adult's account;
- 8 (4) an attorney or financial professional known to
- 9 <u>represent or have represented, or to assist in the management</u>
- of the financial affairs of the older adult;
- 11 (5) a parent, spouse, adult child, sibling or other
- 12 known family member or close associate of an older adult; or
- 13 (6) any other person in a position of trust with respect
- to the older adult as provided by 18 Pa.C.S. § 3922.1(f)
- 15 <u>(relating to financial exploitation of an older adult or</u>
- 16 <u>care-dependent person</u>).
- 17 "Designated representative of a financial institution." An
- 18 individual provided immunity from suit for disclosing suspected
- 19 financial exploitation by 12 U.S.C. § 3423 (relating to immunity
- 20 from suit for disclosure of financial exploitation of senior
- 21 citizens).
- 22 "Fiduciary." A quardian, custodian, trustee, agent, personal
- 23 representative or other person authorized or required to act on
- 24 behalf of an older adult.
- 25 "Financial exploitation." As defined in 18 Pa.C.S. § 3922.1.
- 26 "Financial institution." Any person defined as a "financial"
- 27 <u>institution" under 31 CFR Subt. B Ch. X (relating to Financial</u>
- 28 Crimes Enforcement Network, Department of the Treasury) that is
- 29 required to file suspicious activity reports.
- 30 <u>Section 602. Voluntary reporting of financial exploitation.</u>

- 1 (a) Reporting. -- Notwithstanding any law limiting or
- 2 prohibiting disclosure, a fiduciary or designated representative
- 3 of a financial institution having reasonable cause to believe
- 4 that financial exploitation of an older adult may have occurred,
- 5 <u>may have been attempted or is being attempted, may report such</u>
- 6 information to the agency which is the local provider of
- 7 protective services, or may report the information to a law
- 8 enforcement agency or the department. A report made to an agency
- 9 <u>under this subsection shall provide:</u>
- 10 (1) the name, age and address of the older adult;
- 11 (2) the name and address, if known, of the older adult's
- 12 <u>guardian or next of kin;</u>
- 13 (3) the name and address of the financial institution or
- fiduciary and contact information for the individual
- 15 <u>submitting the report;</u>
- 16 <u>(4) the nature of the suspected financial exploitation</u>
- of the older adult; and
- 18 (5) any specific comments, observations or other
- 19 information directly related to the alleged incident, the
- 20 <u>older adult and suspected perpetrator of the financial</u>
- 21 exploitation a THE financial institution or fiduciary
- 22 determines is needed to facilitate investigation of the
- 23 report.
- 24 (b) Assistance by persons reasonably associated with an
- 25 older adult.--At the same time a report is made under subsection

- 26 (a) regarding the older adult, notwithstanding any law limiting
- 27 or prohibiting disclosure, the fiduciary or designated
- 28 representative may provide information regarding the report to a
- 29 person reasonably associated with the older adult sufficient to
- 30 enable the person to consult with or assist the older adult in

- 1 avoiding or remedying the suspected financial exploitation, or
- 2 <u>exercise any fiduciary powers it possesses to protect the older</u>
- 3 adult, unless the financial institution has reason to believe
- 4 the person is knowingly engaged in or facilitating the financial
- 5 <u>exploitation of the older adult.</u>
- 6 (c) Access to records. -- Notwithstanding the provisions of
- 7 section 304:
- 8 (1) A report authorized by this section may include, or
- 9 <u>may be subsequently supplemented by, records of the older</u>
- 10 adult the financial institution or fiduciary believes are
- 11 <u>needed to provide protective services to the older adult.</u>
- 12 (2) If records needed to determine if an older adult
- subject to a report as authorized by this section are
- 14 provided by a financial institution or fiduciary as
- authorized by paragraph (1), and the older adult, or a
- fiduciary acting on behalf of the older adult, does not
- 17 provide consent to the agency to access such records, the
- agency may issue an order, subject to 2 Pa.C.S. Chs. 5 Subch.
- 19 A (relating to practice and procedure of Commonwealth
- 20 agencies) and 7 Subch. A (relating to judicial review of
- 21 Commonwealth agency action), directing the production of such
- 22 records that relate to the financial transactions of the
- 23 older adult for a period of time up to 60 days prior to the
- 24 date of the report and the first reported incident of actual
- 25 or suspected financial exploitation. Other records shall only
- 26 be available to the extent provided by section 304.

4	Section 604. Voluntary refusal of disbursements and
. 5	transactions.
- 6	(a) Reasonable beliefIf a designated representative or
_7	other employee of a financial institution or a fiduciary
8 .	reasonably believes, after initiating an internal review of a
9	disbursement or transaction, that financial exploitation of an
20	older adult may have occurred, may have been attempted or is
21	being attempted, the financial institution or fiduciary may
22	refuse to disburse money, or engage in a transaction, to prevent
23	financial exploitation of an older adult with respect to:
24	(1) an account of the older adult;
25	(2) an account on which the older adult is a
26	beneficiary, including a trust or guardianship account; and
27	(3) an account of a person suspected of perpetrating
28	financial exploitation of an older adult.
29	(b) Request by area agency on aging or law enforcement
30	agency In addition to the authorization provided under

- 1 subsection (a), a financial institution or fiduciary may refuse
- 2 to disburse money or engage in a transaction with respect to the
- 3 accounts designated in subsection (a) if an area agency on aging
- 4 or law enforcement official requests the financial institution
- 5 or fiduciary to do so or provides information to the financial
- 6 <u>institution or fiduciary demonstrating that it is reasonable to</u>
- 7 believe that financial exploitation of an older adult may have
- 8 occurred, may have been attempted or is being attempted.
- 9 (c) Discretion. -- A financial institution or fiduciary is not
- 10 required to refuse to disburse money or engage in a transaction
- 11 <u>as authorized under subsection (a) or (b), but may use its sole</u>
- 12 <u>discretion to determine whether to refuse to disburse money</u>
- 13 <u>based on the information available to the financial institution</u>
- 14 <u>or fiduciary.</u>
- 15 <u>(d) Duties.--Except as provided under Federal or State law,</u>
- 16 <u>if a financial institution or fiduciary refuses to disburse</u>
- 17 money or engage in a transaction as authorized by this section
- 18 to protect an older adult, the designated representative of the
- 19 financial institution or the fiduciary shall:
- 20 (1) make an immediate oral report and file a written
- 21 report containing the information required for a voluntary
- 22 report under section 602(a) within two business days;
- 23 (2) notify the older adult, and if requested provide
- 24 additional information, in the manner provided for
- notification by an agency under section 308(a); and
- 26 (3) within two business days, make a reasonable effort
- 27 <u>to notify, orally or in writing, each person authorized to</u>
- transact business on the account, that is a beneficiary of
- 29 <u>the account or that has been authorized by the older adult to</u>
- 30 receive notifications regarding account activity, except for

1	a person reasonably believed to have engaged in suspected or
2	attempted financial exploitation of the older adult or a
3	payable on death beneficiary designated not to be notified
4	prior to the death of the older adult.
5	(e) Notice of refused disbursement or transaction A
6	notification required by subsection (d)(3) shall be sufficient
7	<pre>if it:</pre>
8	(1) states that the financial institution or fiduciary
9	has temporarily blocked the disbursement of money or delayed
10	the execution of transactions as authorized by this section
11	to protect an older adult from financial exploitation;
12	(2) provides the name of the financial institution or
13	fiduciary and the name and telephone number of a contact
14	person representing the financial institution or fiduciary;
15	<u>and</u>
16	(3) identifies the account or transaction to which the
17	notification applies.
18	(f) ExpirationExcept as provided under subsection (h), a
19	refusal to disburse money or engage in a transaction as
20	authorized by this section shall expire upon the sooner of the
21	following:
22	(1) issuance of a court order directing the financial
23	institution or fiduciary to make the disbursement or engage
24	in the transaction;
25	(2) a determination by the financial institution or
26	fiduciary based on its sole review and discretion to
27	authorize the disbursement or transaction; or
28	(3) 15 SEVEN business days after the financial <-
29	institution or fiduciary first refused to disburse the money

or engage in the transaction.

- 1 (g) Extension of expiration. -- A financial institution or
- 2 <u>fiduciary may extend the expiration date of its refusal as</u>
- 3 provided in subsection (f)(3) by an additional 25 15 business
- 4 days if a request is made for a court order as authorized by
- 5 <u>subsection</u> (h) by a financial institution or fiduciary, or by
- 6 the local agency on aging, the department or a law enforcement
- 7 agency to block or extend the refused disbursement or
- 8 transaction.
- 9 (h) Order.--A court of competent jurisdiction may enter an
- 10 order blocking a disbursement or transaction, or further
- 11 <u>delaying a disbursement or transaction, to protect an older</u>
- 12 <u>adult from suspected financial exploitation or order other</u>
- 13 <u>actions to protect the older adult.</u>
- 14 (i) Recordkeeping. -- A request of an area agency on aging or
- 15 <u>a law enforcement official to terminate or extend a refusal to</u>
- 16 <u>disburse money or engage in a transaction as authorized by this</u>
- 17 section shall be documented in writing.
- 18 Section 605. Standing of financial institutions and
- 19 fiduciaries.
- 20 (a) Initiation of proceedings. -- If a financial institution
- 21 or fiduciary has a reasonable cause to believe an older adult is
- 22 subject to an imminent and substantial risk of financial
- 23 <u>exploitation</u>, the financial institution or fiduciary may
- 24 initiate a proceeding in a court of competent jurisdiction to:
- 25 (1) extend the period of time the disbursement of money
- or transactions may be refused under section 604, or prohibit
- 27 <u>specific disbursements or transactions;</u>
- 28 (2) request an order necessary to protect the accounts
- 29 or assets of an older adult, or in which the older adult has
- 30 interests;

Τ.	(3) request the appointment of a conservator of guardian
2	of the estate of an older adult;
3	(4) remove the powers of a fiduciary engaged in the
4	financial exploitation of an older adult;
5	(5) modify an order issued by an area agency on aging or
6	the department issued under this act or other law to protect
7	an older adult from suspected financial exploitation; or
8	(6) grant other appropriate relief.
9	(b) Notice to area agency on aging Prior to initiating a
10	proceeding under this subsection, at least 24 hours' prior
11	notice must be given to the area agency on aging for the county
12	in which the proceeding is initiated and an offer made to
13	consult with the agency regarding the proceeding, unless
14	delaying the initiation of the proceeding will threaten an older
15	adult with immediate and irreparable injury pursuant to the
16	standards applicable for an application for special relief
17	before notice of a hearing under Pa.R.C.P Rule 1531 (relating to
18	special relief, injunctions). A copy of a petition initiating a
19	proceeding under this section shall be provided to the area
20	agency on aging for the county in which a proceeding is
21	initiated.
22	(c) Intervention
23	(1) The area agency on aging in the county in which a
24	petition is filed under this section and the department
25	shall have a right to intervene as a party to the
26	proceeding.
27	(2) A financial institution or fiduciary shall have the
28	right to intervene as a party to a proceeding initiated by
29	an area agency on aging or the department under this act to
30	provide protective services to an older adult customer of a

- financial institution or to an individual to whom a
- 2 <u>fiduciary owns a duty of care.</u>
- 3 Section 606. Access to reports and communications regarding
- 4 <u>investigations.</u>
- 5 <u>Notwithstanding the requirements of section 304, an area</u>
- 6 agency on aging may disclose and discuss with a financial
- 7 <u>institution or fiduciary reports of the suspected financial</u>
- 8 exploitation of an older adult and the results of the
- 9 <u>investigation of such reports to the extent reasonably necessary</u>
- 10 to facilitate the financial institution's or fiduciary's
- 11 decision under section 604 to refuse to disburse money or engage
- 12 in a transaction or to terminate or seek an extension of its
- 13 refusal to do so.
- 14 Section 607. Immunity and defenses.
- 15 (a) Immunity. -- Except as provided under subsection (c), a
- 16 financial institution or fiduciary and its directors, officers,
- 17 designated representatives, employees or agents shall not be
- 18 subject to a claim for damages or other civil or criminal
- 19 liability for taking or failing to take any action authorized,
- 20 but not required by this chapter, to:
- 21 (1) identify and report financial exploitation under
- 22 section 602(a);
- 23 (2) notify a person reasonably associated with an older
- adult under section 602(b);
- 25 (3) provide access to records and information under
- 26 sections 602(c)(1) and (2) and 606;
- 27 (4) refuse to allow the disbursement of funds or a
- transaction under section 604; or
- 29 (5) initiate or participate in judicial proceedings
- 30 under section 605.

- 1 (b) Additional immunities and defenses. -- Notwithstanding any
- 2 <u>other law to the contrary:</u>
- 3 (1) The refusal by a financial institution to engage in
- 4 <u>a transaction authorized under this chapter shall not</u>
- 5 <u>constitute the wrongful dishonor of an item under 13 Pa.C.S.</u>
- 6 § 4402 (relating to liability of bank to customer for
- 7 <u>wrongful dishonor; time of determining insufficiency of</u>
- 8 <u>account</u>).
- 9 (2) A reasonable belief that payment of a check will
- 10 facilitate the financial exploitation of an older adult shall
- 11 constitute reasonable grounds to doubt the collectability of
- the item for purposes of 12 U.S.C. Chs. 41 (relating to
- 13 <u>expedited funds availability</u>) and 50 (relating to check
- truncation) and 12 CFR Pt. 229 (relating to availability of
- funds and collection of checks).
- 16 <u>(c) Limitation.--The immunities and defenses provided under</u>
- 17 this section shall not apply to a financial institution or
- 18 fiduciary or a director, officer, designated representative,
- 19 employee or agent of a financial institution or fiduciary that
- 20 intentionally or knowingly engages in the financial exploitation
- 21 of an older adult.
- 22 Section 608. Electronic records and signatures.
- 23 Any requirements of this chapter requiring a written request,
- 24 authorization or report may be satisfied by the use of
- 25 electronic records and signatures as authorized by the act of
- 26 December 16, 1999 (P.L.971, No.69), known as the Electronic
- 27 <u>Transactions Act.</u>
- 28 Section 2. This act shall take effect in 60 days.
