AN ACT

Amending the act of May 17, 1921 (P.L.682, No.284), entitled "An <--2 act relating to insurance; amending, revising, and consolidating the law providing for the incorporation of 3 insurance companies, and the regulation, supervision, and protection of home and foreign insurance companies, Lloyds associations, reciprocal and inter insurance exchanges, and 6 7 fire insurance rating bureaus, and the regulation and 8 supervision of insurance carried by such companies, associations, and exchanges, including insurance carried by the State Workmen's Insurance Fund; providing penalties; and 10 repealing existing laws," in casualty insurance, providing 11 for coverage for blood pressure monitors. 12 AMENDING THE ACT OF JUNE 13, 1967 (P.L.31, NO.21), ENTITLED "AN <--13 ACT TO CONSOLIDATE, EDITORIALLY REVISE, AND CODIFY THE PUBLIC 14 WELFARE LAWS OF THE COMMONWEALTH, " IN PUBLIC ASSISTANCE, 15 PROVIDING FOR COVERAGE FOR BLOOD PRESSURE MONITORS. 16 17 The General Assembly of the Commonwealth of Pennsylvania 18 hereby enacts as follows: 19 Section 1. - 13 <u>"Postpartum" means within one year of delivery or the end of</u>
- 14 pregnancy.
- 15 Section 2. This act shall take effect in 60 days.

- 19 SECTION 443.15. COVERAGE FOR BLOOD PRESSURE MONITORS.--(A)
- 20 A GOVERNMENT PROGRAM SHALL PROVIDE COVERAGE FOR MEDICALLY
- 21 NECESSARY HOME BLOOD PRESSURE MONITORS THAT HAVE BEEN VALIDATED
- 22 FOR CLINICAL ACCURACY FOR PREGNANT OR POSTPARTUM ENROLLEES FOR
- 23 <u>EACH PREGNANCY</u>.
- 24 (B) AS USED IN THIS SECTION, THE FOLLOWING WORDS AND PHRASES
- 25 SHALL HAVE THE MEANINGS GIVEN TO THEM IN THIS SUBSECTION UNLESS
- 26 THE CONTEXT CLEARLY INDICATES OTHERWISE:
- 27 <u>"ENROLLEE." AN INDIVIDUAL ENTITLED TO RECEIVE HEALTH CARE</u>
- 28 <u>SERVICES UNDER A GOVERNMENT PROGRAM.</u>
- 29 "GOVERNMENT PROGRAM." A PROGRAM OF GOVERNMENT-SPONSORED OR
- 30 GOVERNMENT-SUBSIDIZED HEALTH CARE COVERAGE, INCLUDING:

- 4 (2) SUBDIVISION (F) OF ARTICLE IV.
- 5 "POSTPARTUM." WITHIN ONE YEAR OF DELIVERY OR THE END OF
- 6 PREGNANCY.
- 7 SECTION 2. THIS ACT SHALL TAKE EFFECT IN 60 DAYS.
