1 2 3	Amending Title 71 (State Government) of the Pennsylvania Consolidated Statutes, in boards and offices, providing for Commonwealth Office of Management and Budget.
4	The General Assembly of the Commonwealth of Pennsylvania

- 4 The following words and phrases when used in this chapter
- 5 shall have the meanings given to them in this section unless the
- 6 <u>context clearly indicates otherwise:</u>
- 7 <u>"Administrative Code of 1929." The act of April 9, 1929</u>
- 8 (P.L.177, No.175), known as The Administrative Code of 1929.
- 9 <u>"Continuous improvement process system." A management</u>
- 10 methodology system that combines tools to improve process speed
- 11 and reduce waste with data-driven project analysis to provide
- 12 products and services with improved quality at a lower cost. The
- 13 term may involve any of the following strategies:
- 14 (1) Developing a process map that describes the lean
- government principles or another widely accepted business
- 16 <u>process improvement system by which an executive agency</u>
- 17 engages in specific activities that have the purpose of
- increasing efficiency and eliminating waste in the processes
- 19 used to deliver goods and services to taxpavers and customers
- of this Commonwealth. This strategy includes the measurement
- 21 of the outcomes regarding increased efficiency and the
- 22 elimination of waste and procedures by which the executive
- 23 <u>agency produces goods or serves its customers.</u>
- 24 (2) Engaging in specific activities to rapidly improve
- an executive agency's processes that will increase value or
- decrease staff time, inventory, defects, overproduction,
- 27 <u>complexity, delays or excessive movement.</u>
- 28 (3) Involving executive agency employees at all levels
- 29 to map the executive agency's processes and recommend
- improvements, with specific importance placed on the

- involvement of executive agency employees closest to the
- 2 customer or end user of the State government product or
- 3 service.
- 4 (4) Providing the means to measure each process in order
- 5 <u>to demonstrate the effectiveness of each process or process</u>
- 6 <u>improvement.</u>
- 7 (5) Training executive agency employees to mentor and
- 8 <u>train other executive agency employees in continuous</u>
- 9 <u>improvement process systems.</u>
- 10 "Director." The director of the office.
- 11 "Executive agency." Any of the following:
- 12 <u>(1) The Governor's Office.</u>
- 13 (2) A department, board, commission, authority or other
- 14 agency of the Commonwealth that is subject to the policy
- 15 <u>supervision and control of the Governor.</u>
- 16 (3) The Office of Lieutenant Governor.
- 17 (4) An independent department.
- 18 (5) An independent agency.
- 19 "Executive board." As specified in section 204 of the
- 20 Administrative Code of 1929.
- "Independent agency." A board, commission, authority or

20	Administration or the Office of Policy and Planning and shall
21	also include, where applicable, Federal grants and funds and
22	other benefits from any Federal program.
23	(d) Status of employees All personnel transferred under
24	this chapter shall retain any civil service employment status
25	assigned to the personnel.

27	(a) Office of the Budget
28	(1) The Office of the Budget shall be known as the
29	Bureau of Budget and Financial Management.
30	(2) A reference to the Office of the Budget in a statute

of regulation shall be accomed a reference to the office.
(3) To provide an efficient and cost-minimizing
transition, licenses, contracts, deeds and other official
actions of the Office of the Budget OFFICE OR ANY BUREAU <
SPECIFIED IN THIS SUBSECTION shall not be affected by the use
of the designation as Bureau of Budget and Financial <

(ii) The strategic plan under section 4318 shall

26	be affected by the use of the designation as Bureau of Policy <
27	and Planning THE OFFICE OF POLICY AND PLANNING. The Office of
28	Policy and Planning OFFICE may continue to use the name <
29	"Office of Policy and Planning" on badges, licenses,
30	contracts, deeds, stationery and other official documents

(c) Appointments. -- The director shall appoint the executive <--

- 23 Innovation, Management and Efficiency is established within the
- 24 office.
- 25 (b) Executive director.--The Governor's Office shall be
- 26 headed by an executive director who shall be appointed by the
- 27 <u>director and who shall report to the director.</u>
- 28 (c) Support services. -- The office shall provide all support
- 29 services and staff for the Governor's Office.
- 30 (d) Powers and duties. -- The Governor's Office shall:

Τ	(1) Deliver cost savings to the residents of this
2	Commonwealth through multiagency efficiencies, productivity
3	improvements and cost-saving innovations.
4	(2) Remain fully and continuously engaged with executive

7	data and collaboration across executive agencies in alignment
8	with the priorities of the Governor.

10	organizations and local communities to leverage resources

12	(5) Focus on citizen engagement to further improve user-
13	oriented services and realize cost efficiencies through the
14	use of modern platforms.
15	(6) Increase the involvement and participation of State
16	employees at all levels in improving management, reducing
17	waste and improving the delivery of State services.
18	(7) Work collaboratively with the heads of executive
19	agencies to identify opportunities for streamlining the
20	operation of government and generating new efficiencies.
21	(8) Develop and implement strategies for implementing
22	the opportunities specified in paragraph (7).
23	(9) Identify barriers to the implementation of
24	transformational efforts and recommend strategies for
25	addressing these barriers.
26	(10) Provide training to State employees in continuous
27	<pre>improvement.</pre>
28	(e) Cooperation by executive agencies
29	(1) All executive agencies shall cooperate with the
30	<pre>Governor's Office.</pre>

1	(2) Executive agency heads shall identify key staff to
2	form innovation teams, which shall be responsible for
3	<pre>implementing the initiatives identified by the bureau</pre>
4	GOVERNOR'S OFFICE. Innovation teams shall recommend to the
5	<pre>bureau GOVERNOR'S OFFICE new opportunities to reduce costs</pre>
6	and improve efficiency.
7	(f) Definitions As used in this section, the following
8	words and phrases shall have the meanings given to them in this
9	subsection unless the context clearly indicates otherwise:
10	"Governor's Office." The Governor's Office of
11	Transformation, Innovation, Management and Efficiency
12	established under this section.
13	§ 4318. Strategic plan.
14	(a) DevelopmentWithin 60 days of the effective date of
15	this section, the Governor shall:
16	(1) subject to subsection (b), contract with a qualified
17	third party to develop a strategic plan under this section;
18	<u>or</u>
19	(2) execute a memorandum of understanding with the
20	Legislative Budget and Finance Committee to develop a
21	strategic plan under this section.
22	(b) Third-party contract The Governor may enter into a
23	contract with a qualified third-party organization under this
24	section if the organization:
25	(1) has experience with large corporate mergers of a
26	company which has more than 500 employees;
27	(2) has experience assisting in the merging of
28	government agencies in other states; and
29	(3) utilizes continuous improvement process systems to
30	strengthen the efficiency and delivery of service of agencies

- or corporations undergoing a merger.
- 2 (c) Parameters. -- The strategic plan under this section shall
- 3 detail the merger of the Office of the Budget, the Department of
- 4 General Services, the Office of Administration and the Office of
- 5 Policy and Planning, in accordance with the provisions of this
- 6 chapter, and shall provide for:
- 7 (1) A 20% reduction in administrative costs.
- 8 (2) The consolidation of similar programs.
- 9 (3) The elimination of redundancy to maximize taxpayer
- dollars.
- 11 (4) The improvement of agency services to residents of
- this Commonwealth at a lower cost to taxpayers.
- 13 (5) A continuous improvement process system throughout
- 14 <u>executive agencies.</u>
- 15 (6) Financial transparency to residents of this
- 16 Commonwealth.
- 17 (7) A uniform accounting system and prudent financial
- 18 management throughout executive agencies.
- 19 <u>(8) THE APPORTIONMENT OF PERSONNEL, APPROPRIATIONS,</u>
- 20 <u>EQUIPMENT AND OTHER ITEMS AND MATERIAL TRANSFERRED TO THE</u>
- 21 OFFICE UNDER SECTION 4313(C) (RELATING TO GENERAL DUTIES OF
- 22 OFFICE AND TRANSFER PROVISIONS).
- 23 (d) Submittal.--No later than 210 days after the effective
- 24 dates of this section, the strategic plan under this section
- 25 shall be submitted to the General Assembly for review and any
- 26 hearings deemed necessary.
- 27 Section 2. All other acts or parts of acts are repealed
- 28 insofar as they are inconsistent with this act.
- 29 Section 3. Except as otherwise provided in 71 Pa.C.S. Ch.
- 30 43, all activities regarding the powers and duties under 71

- 1 Pa.C.S. Ch. 43 which were initiated under the Office of the
- 2 Budget, the Department of General Services, the Office of
- 3 Administration or the Office of Policy and Planning shall
- 4 continue and remain in full force and effect and may be
- 5 completed under 71 Pa.C.S. Ch. 43. Orders, regulations, rules
- 6 and decisions which were made under the authority of the Office
- 7 of the Budget, the Department of General Services, the Office of
- 8 Administration or the Office of Policy and Planning regarding
- 9 the powers and duties under 71 Pa.C.S. Ch. 43 and which are in
- 10 effect on the effective date of 71 Pa.C.S. Ch. 43 shall remain
- 11 in full force and effect until revoked, vacated or modified
- 12 under 71 Pa.C.S. Ch. 43. Contracts, obligations and collective
- 13 bargaining agreements entered into under the authority of the
- 14 Office of the Budget, the Department of General Services, the
- 15 Office of Administration or the Office of Policy and Planning
- 16 are not affected nor impaired by the transfer of powers and
- 17 duties under 71 Pa.C.S. Ch. 43.
- 18 Section 4. Any expenditures needed to implement this act
- 19 shall be paid using encumbered funds of the respective executive
- 20 agency.
- 21 Section 5. Within 10 days of the nomination under 71 Pa.C.S.
- 22 § 4316(a), the Secretary of the Commonwealth shall provide
- 23 notice of the nomination to the Legislative Reference Bureau,
- 24 which shall publish the notice in the Pennsylvania Bulletin.
- 25 Section 6. This act shall take effect as follows:
- 26 (1) The following shall take effect immediately:
- 27 (i) This section and section 5 of this act.
- 28 (ii) The addition of 71 Pa.C.S. §§ 4301, 4302, 4303,
- 29 4316 and 4318.
- 30 (2) The remainder of this act shall take effect 30 days

- 1 after publication in the Pennsylvania Bulletin of the notice
- 2 under section 5 of this act.
