2 Section 2. Section 1543(b)(1)(i) and (ii) and (1.1)(i) of 3 Title 75 are amended to read:

4 § 1543. Driving while operating privilege is suspended or5 revoked.

- 7 (b) Certain offenses.--
- 8

(1) The following shall apply:

9 A person who drives a motor vehicle on a highway (i) 10 or trafficway of this Commonwealth at a time when the 11 person's operating privilege is suspended or revoked as a 12 condition of acceptance of Accelerated Rehabilitative 13 Disposition for a violation of section 3802 (relating to 14 driving under influence of alcohol or controlled 15 substance) or the former section 3731, because of a 16 violation of section 1547(b)(1) (relating to suspension for refusal) or 3802 or former section 3731 or is 17 suspended under section 1581 (relating to Driver's 18 19 License Compact) for an offense substantially similar to 20 a violation of section 3802 or former section 3731 shall, 21 upon a first conviction, be guilty of a summary offense 2.2 and shall be sentenced to pay a fine of \$500 and to 23 undergo imprisonment for [a period of not less than] 60 24 days [nor more than 90 days].

(ii) A second violation of this paragraph shall
constitute a summary offense and, upon conviction of this
paragraph, a person shall be sentenced to pay a fine of
\$1,000 and to undergo imprisonment for [not less than] 90
days.

1 (1.1)(i) A person who has an amount of alcohol by 2 weight in his blood that is equal to or greater than .02% 3 at the time of testing or who at the time of testing has in his blood any amount of a Schedule I or nonprescribed 4 5 Schedule II or III controlled substance, as defined in the act of April 14, 1972 (P.L.233, No.64), known as The 6 7 Controlled Substance, Drug, Device and Cosmetic Act, or 8 its metabolite or who refuses testing of blood or breath 9 and who drives a motor vehicle on any highway or 10 trafficway of this Commonwealth at a time when the 11 person's operating privilege is suspended or revoked as a 12 condition of acceptance of Accelerated Rehabilitative Disposition for a violation of section 3802 or former 13 14 section 3731 or because of a violation of section 1547(b) 15 (1) or 3802 or former section 3731 or is suspended under section 1581 for an offense substantially similar to a 16 17 violation of section 3802 or former section 3731 shall, 18 upon a first conviction, be guilty of a summary offense 19 and shall be sentenced to pay a fine of \$1,000 and to 20 undergo imprisonment for [a period of not less than] 90 21 days.
