16	<u>§ 7901. Definitions.</u>
17	The following words and phrases when used in this chapter

1	shall have the meanings given to them in this section unless the	
2	context clearly indicates otherwise:	
3	"Audio or visual recording device." A device which	
4	photographs, videotapes, electronically depicts, films or	
5	otherwise records images and or sounds.	
6	"Host." A person who, by any means, including listing with a	
7	hosting platform, advertises, licenses or registers with an	
8	innkeepers' group, convention listing association, travel	
9	publication or similar association or with a government agency,	
10	offers a residential unit to provide overnight lodging for	
11	consideration to a person seeking transient lodging.	
12	"Hosting platform." A publicly accessible Internet website	
13	on which, in exchange for a fee or other charge, an owner or	
14	lessee of a residential unit or hotel or a room or space in a	
15	residential unit or hotel may advertise and conduct a	
16	transaction for the rental of the residential unit or hotel for	
17	the purposes of transient lodging. The term does not include a	
18	publicly accessible Internet website operated by or on behalf of	
19	a hotel or hotel corporation that facilitates the booking of	
20	lodging reservations solely for the hotel or the hotel	
21	corporation's owned or managed hotels and franchisees.	
22	§ 7902. Unlawful use of recording devices in residential units	
23	used for transient lodging.	
24	(a) Offense definedA person commits the offense of	
25	unlawful use of a recording device in a residential unit used	
26	for transient lodging if the person audially or visually	
27	photographs, videotapes, electronically depicts, films or	
28	otherwise records another person using an audio or visual	
29	recording device which is not located in plain sight without	
30	disclosure and consent by the person under this subsection. The

1 following shall apply:

2	(1) A host shall disclose the use and location of any
3	audio or visual recording device located in a residential
4	unit used for the purpose of transient lodging.
5	(2) Disclosure of audio or visual recording devices
6	shall be provided in the residential unit's listing on the
7	hosting platform and displayed in a visible location within
8	the residential unit.
9	(3) A person shall be considered to provide consent to
10	be recorded at the host's residential unit, by agreeing to
11	terms of occupying the residential unit if disclosure
12	requirements under this section have been fulfilled.
13	(b) PenaltyA person who violates subsection (a) commits a
14	felony of the third degree.
15	Section 2. This act shall take effect in 60 days.
