## AN ACT

- Amending the act of May 1, 1933 (P.L.103, No.69), entitled, as reenacted and amended, "An act concerning townships of the 1
- 2
- second class; and amending, revising, consolidating and 3
- changing the law relating thereto," in auditors and 4
- accountants, further providing for auditor's compensation. 5
- 6 The General Assembly of the Commonwealth of Pennsylvania
- 7 hereby enacts as follows:
- 8 Section 1. Section 902 of the act of May 1, 1933 (P.L.103,
- No.69), known as The Second Class Township Code, amended June
- 10 22, 1999 (P.L.114. No.17), is amended to read:
- 11 Section 902. Auditor's Compensation. -- (a) Each auditor
- 12 shall receive [ten dollars (\$10)] a base amount of fifteen
- 13 dollars (\$15), subject to adjustment under subsection (d), for
- 14 each hour necessarily employed in the duties of the office upon
- 15 presentation to the board of supervisors of an itemized listing
- 16 of the dates, times, places and hours worked to perform the
- 17 audit. No auditor in a township having a population of ten
- 18 thousand or less is entitled to receive a base amount of more
- than [one thousand dollars (\$1,000)] one thousand five hundred 19
- dollars (\$1,500), subject to adjustment under subsection (d), 20

- 1 for completing the annual audit, settlement and adjustment. No
- 2 auditor in a township having a population in excess of ten
- 3 thousand is entitled to receive a base amount of more than [two
- 4 thousand dollars (\$2,000)] three thousand dollars (\$3,000),
- 5 <u>subject to adjustment under subsection (d)</u>, for completing the
- 6 annual audit, settlement and adjustment.
- 7 (b) In addition to the time actually used by the board of
- 8 auditors to complete the audit, settlement and adjustment, each
- 9 auditor may be compensated by a base amount at the rate of [ten
- 10 dollars (\$10)] fifteen dollars (\$15), subject to adjustment
- 11 <u>under subsection (d)</u>, each hour for not more than fifty hours to
- 12 audit the accounts of any public official who handles public
- 13 funds when a vacancy occurs in the office of the public
- 14 official.
- 15 (c) Each auditor shall be reimbursed for travel costs
- 16 incurred in the performance of the auditing duties at the rate
- 17 established by the board of supervisors under the act of July
- 18 20, 1979 (P.L.156, No.51), referred to as the Uniform Mileage
- 19 Fee Law, and for other expenses, including postage, notary fees
- 20 or publication costs, incurred during the audit.
- 21 (d) Adjustments to the base amounts specified under
- 22 subsections (a) and (b) shall be made as follows:
- 23 (1) The board of supervisors shall consult the Consumer
- 24 Price Index for all Urban Consumers (CPI-U) for the
- 25 <u>Pennsylvania, New Jersey, Delaware and Maryland area as</u>
- 26 published by the United States Department of Labor, Bureau of
- 27 <u>Labor Statistics</u>, for the twelve-month period ending December
- 28 <u>31, 2016, and for each successive twelve-month period</u>
- 29 thereafter.
- 30 (2) If the board of supervisors determines that there is no

- 1 positive percentage change, there shall be no adjustment to the
- 2 base amounts for the following calendar year.
- 3 (3) If the board of supervisors determines that there has
- 4 been an increase in the CPI-U, then the board of supervisors
- 5 shall adjust the auditor's compensation to the nearest dollar
- 6 <u>amount and pass a resolution detailing auditor's compensation</u>
- 7 for the following calendar year.
- 8 (4) The determinations and adjustments required under this
- 9 subsection shall be made in the period between October 1 and
- 10 November 15 of the year following the effective date of this
- 11 subsection and annually between October 1 and November 15 of
- 12 <u>each year thereafter.</u>
- 13 (5) Any adjustments determined by the board of supervisors
- 14 shall take effect on January 1 of the following calendar year.
- 15 Section 2. This act shall take effect in 60 days.
