AN ACT

Amending the act of April 12, 1951 (P.L.90, No.21), entitled "An 1 act relating to alcoholic liquors, alcohol and malt and 2 brewed beverages; amending, revising, consolidating and changing the laws relating thereto; regulating and 3 4 restricting the manufacture, purchase, sale, possession, 5 consumption, importation, transportation, furnishing, holding 6 7 in bond, holding in storage, traffic in and use of alcoholic liquors, alcohol and malt and brewed beverages and the 8 persons engaged or employed therein; defining the powers and 9 duties of the Pennsylvania Liquor Control Board; providing 10 for the establishment and operation of State liquor stores, 11 for the payment of certain license fees to the respective 12 municipalities and townships, for the abatement of certain 13 nuisances and, in certain cases, for search and seizure 14 without warrant; prescribing penalties and forfeitures; 15 providing for local option, and repealing existing laws," in 16 17 licenses and regulations and liquor, alcohol and malt and brewed beverages, further providing for extension of licensed 18 service area and issuance of off-premises catering permits. 19 20 The General Assembly of the Commonwealth of Pennsylvania 21 hereby enacts as follows:

22 Section 1. Section 417(a.1)(4) and (a.3) of the act of April 23 12, 1951 (P.L.90, No.21), known as the Liquor Code, are amended 24 to read: 25 Section 417. Extension of Licensed Service Area and Issuance 1 of Off-premises Catering Permits.--* * *

2 (a.1) Notwithstanding any other provision of this act, the 3 following shall apply to the temporary extension of the licensed 4 premises:

6 (4) A filing fee may [not] be required from an applicant7 under this subsection.
