## AN ACT

(Municipalities Generally) of the Pennsylvania Consolidated Statutes, in selection and retention of judicial officers, further providing for continuing education requirement; and, 3 4 in municipal police education and training, further providing 5 for powers and duties of Municipal Police Officers' Education 7 and Training Commission. The General Assembly of the Commonwealth of Pennsylvania 8 hereby enacts as follows: 10 Section 1. Section 3118(a) of Title 42 of the Pennsylvania Consolidated Statutes is amended to read: 11 § 3118. Continuing education requirement. 12 Magisterial district judges.--13 14 (1) Every magisterial district judge shall complete a 15 continuing education program each year equivalent to not less 16 than 32 hours per year in such courses or programs as are 17 approved by the board. At least every six years, the program

4	(2) If a magisterial district judge fails to meet these	
5	continuing education requirements, such judge shall be

9	time the failure to meet the continuing education	
10	requirements shall be grounds for the Supreme Court, after a	
11	hearing, to declare a vacancy in that district.

15	§ 2164. Powers and duties of commission.	
16	The powers and duties of the commission shall be as follows:

29	Section 3. This act shall take effect in 60 days.
