AN ACT

- Designating a portion of State Route 309 North in Lynn Township, Lehigh County, between the intersections of Northwest Road and Long Court and Mosserville Road and Mountain Road, as the Lance Corporal Brandon J. Van Parys Memorial Road. 4 The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows: 7 Section 1. Lance Corporal Brandon J. Van Parys Memorial Road. 8 (a) Findings. -- The General Assembly finds and declares as follows: 10 Brandon J. Van Parys was born in Norristown, Pennsylvania, on November 2, 1986, and, in 2005, graduated 11 12 from Northwestern Lehigh High School, New Tripoli.
- 13 After high school, he attended Lehigh Career 14 Technical Institute where he took courses in law enforcement.
- 15 In November 2005, motivated to serve his country by the terrorist attacks on September 11, 2001, he enlisted in 16 17 the United States Marine Corps.

- 1 (4) Lance Corporal Van Parys was a member of the 3rd
- 2 Battalion, 6th Marine Regiment, 2nd Marine Division, II
- 3 Marine Expeditionary Force, Camp Lejeune, North Carolina.
- 4 (5) On February 5, 2007, in Anbar Province, Iraq, Lance
- 5 Corporal Van Parys was tragically killed by a rocket-
- 6 propelled grenade while his unit was attempting to secure an
- 7 area along the Euphrates River.
- 8 (6) Lance Corporal Van Parys heroically paid the supreme
- 9 sacrifice for the country he loved.
- 10 (7) Lance Corporal Van Parys was posthumously awarded
- 11 the Purple Heart for his courageous service to his country
- and is survived by his father, Alan, and his wife, Tammy; his
- mother, Catherine Hearn and her husband, Gregory; his
- 14 brothers, Christopher Van Parys, Daniel Van Parys, Samuel
- 15 Hearn and Jesse Hearn; and his sister, Ashley Hearn.
- 16 (b) Designation. -- The portion of State Route 309 North in
- 17 Lynn Township, Lehigh County, between the intersections of
- 18 Northwest Road and Long Court and Mosserville Road and Mountain
- 19 Road is hereby designated as the Lance Corporal Brandon J. Van
- 20 Parys Memorial Road.
- 21 (c) Signs.--The Department of Transportation shall erect and
- 22 maintain appropriate signs to indicate the designation under
- 23 subsection (b).
- 24 Section 2. Effective date.
- This act shall take effect in 60 days.
