15	The General Assembly finds and declares as follows:	
16	(1) Postconviction DNA testing has exonerated wrongfully	
17	convicted individuals and identified real perpetrators of	
18	crimes.	
19	(2) To the extent possible, DNA testing of evidence	
20	before trial is encouraged to help prevent wrongful	
21	convictions and to lead to earlier detection and conviction	
22	of actual perpetrators.	
23	The General Assembly of the Commonwealth of Pennsylvania

- 2 Section 1. Section 9543.1 of Title 42 of the Pennsylvania
- 3 Consolidated Statutes is amended to read:
- 4 § 9543.1. Postconviction DNA testing.
- 5 (a) Motion.--
- 6 (1) An individual convicted of a criminal offense in a
 7 court of this Commonwealth [and serving a term of
 8 imprisonment or awaiting execution because of a sentence of
 9 death] may apply by making a written motion to the sentencing
 10 court at any time for the performance of forensic DNA testing
- on specific evidence that is related to the investigation or
- 12 prosecution that resulted in the judgment of conviction.
- 13 The evidence may have been discovered either prior 14 to or after the applicant's conviction. The evidence shall be 15 available for testing as of the date of the motion. If the 16 evidence was discovered prior to the applicant's conviction, the evidence shall not have been subject to the DNA testing 17 18 requested because the technology for testing was not in 19 existence at the time of the trial or the applicant's counsel 20 did not seek testing at the time of the trial in a case where a verdict was rendered on or before January 1, 1995, or the 21

evidence was subject to the testing, but newer technology

- 23 <u>could provide substantially more accurate and substantially</u>
- 24 <u>probative results</u> or the applicant's counsel sought funds
- from the court to pay for the testing because his client was
- indigent and the court refused the request despite the
- 27 client's indigency.
- 28 (3) A request for DNA testing under this section shall
- be by written petition and shall be filed with the clerk of

- (6) The motion shall explain how, after review of the record of the applicant's trial, there is a reasonable possibility if the applicant is under State supervision, or there is a reasonable probability if the applicant is not under State supervision, or after review of the record of the applicant's guilty plea there is a reasonable probability, that the testing would produce exculpatory evidence that would establish:
 - (i) the applicant's actual innocence of the offense for which the applicant was convicted;
- (ii) in a capital case, the applicant's actual

 innocence of the charged or uncharged conduct

 constituting an aggravating circumstance under section

 9711(d) (relating to sentencing procedure for murder of
 the first degree) if the applicant's exoneration of the

 conduct would result in vacating a sentence of death; or

 (iii) in a capital case, a mitigating circumstance

2 <u>forth in section 9711(c)(1)(iv).</u>

(b) Notice to the Commonwealth. --

- (1) Upon receipt of a motion under subsection (a), the court shall notify the Commonwealth and shall afford the Commonwealth an opportunity to respond to the motion.
- (2) Upon receipt of a motion under subsection (a) or notice of the motion, as applicable, the Commonwealth and the court shall take the steps reasonably necessary to ensure that any remaining biological material in the possession of the Commonwealth or the court is preserved pending the completion of the proceedings under this section.
- 13 (c) Requirements.--In any motion under subsection (a), under 14 penalty of perjury, the applicant shall:
- 15 (1) (i) specify the evidence to be tested;
 - (ii) state that the applicant consents to provide samples of bodily fluid for use in the DNA testing; and
 - (iii) acknowledge that the applicant understands that, if the motion is granted, any data obtained from any DNA samples or test results may be entered into law enforcement databases, may be used in the investigation of other crimes and may be used as evidence against the applicant in other cases.
 - (2) (i) in a sworn statement subject to the penalties under 18 Pa.C.S. §§ 4902 (relating to perjury) and 4903 (relating to false swearing), assert the applicant's actual innocence of the offense for which the applicant was convicted and that the applicant seeks DNA testing for the purpose of demonstrating the applicant's actual

1 (ii) in a capital case: 2 (A) assert the applicant's actual innocence of the charged or uncharged conduct constituting an 3 aggravating circumstance under section 9711(d) 4 [(relating to sentencing procedure for murder of the 5 6 first degree)] if the applicant's exoneration of the conduct would result in vacating a sentence of death; 7 8 or 9 assert that the outcome of the DNA testing (B) 10 would establish a mitigating circumstance under 11 section 9711(e)(7) if that mitigating circumstance 12 was presented to the sentencing judge or jury and facts as to that issue were in dispute at the 13 14 sentencing hearing. 15 (3) present a prima facie case demonstrating that the: 16 identity of or the participation in the crime by the perpetrator was at issue in the proceedings that 17 18 resulted in the applicant's conviction and sentencing; 19 and 20 (ii) DNA testing of the specific evidence, assuming exculpatory results, would establish: 21 22 the applicant's actual innocence of the 23 offense for which the applicant was convicted; 24 in a capital case, the applicant's actual 25 innocence of the charged or uncharged conduct 26 constituting an aggravating circumstance under 27 section 9711(d) if the applicant's exoneration of the 28 conduct would result in vacating a sentence of death;

- (3) Any DNA testing order under this section shall constitute a final order. An applicant or the Commonwealth may appeal a decision denying or granting a DNA testing order in accordance with the Pennsylvania Rules of Appellate Procedure.
- (4) Any decision granting or denying a DNA testing order shall include an explanation by the court of how the testing requested in a motion under subsection (a) has met or fails to have met the requirements under paragraphs (1), (2) and (3).
 - applicable burden established in paragraph (1) or (2), the court may require the Commonwealth to prepare an inventory of evidence related to the case and serve a copy of the inventory to the prosecution, the applicant, the applicant's attorney, if applicable, and the court. The inventory may include, but not be limited to, a list of evidence collected and forensic testing previously done relating to the evidence and the names of agencies that conducted the forensic testing.

- 2 (i) a laboratory mutually selected by the 3 Commonwealth and the applicant;
 - (ii) <u>a laboratory selected by the court that ordered</u>

 the testing if the Commonwealth and the applicant are

 unable to agree on a laboratory[, a laboratory selected

 by the court that ordered the testing]; or
 - (iii) if the applicant is indigent, the testing shall be conducted by the Pennsylvania State Police or, at the Pennsylvania State Police's sole discretion, by a laboratory designated by the Pennsylvania State Police.
 - (2) The costs of any testing ordered under this section shall be paid:
 - (i) by the applicant; or
 - (ii) in the case of an applicant who is indigent, by the Commonwealth of Pennsylvania.
- 17 [Testing conducted by the Pennsylvania State Police 18 shall be carried out in accordance with the protocols and 19 procedures established by the Pennsylvania State Police.] To the extent possible and not inconsistent with best laboratory 20 practices, the testing shall be conducted in a manner that 21 22 ensures that some portion of the sample is preserved for replication of testing. If the laboratory determines it may 23 24 be necessary to consume the entirety of any sample during 25 testing, the laboratory shall inform the prosecution, the 26 applicant and the applicant's attorney, if applicable, of its 27 recommendation and obtain the prosecution and the applicant's 28 consent before proceeding. If the prosecution and the applicant do not consent, the court may issue any appropriate 29 30 order before testing proceeds.

23	(7) To the extent possible, if communication with the
24	parties regarding the testing process and test results is
25	necessary, the testing laboratory shall communicate with
26	counsel for the applicant and the Commonwealth
27	simultaneously.
28	(8) No direct communication involving the testing
29	laboratory without the inclusion of a representative of each
30	party shall occur.

- After the DNA testing conducted under this section has been completed, the applicant may, pursuant to section 9545(b)(2) (relating to jurisdiction and proceedings), during the [60-day] one-year period beginning on the date on which the applicant is notified of the test results, petition to the court for postconviction relief pursuant to section 9543(a)(2)(vi) (relating to eligibility for relief).
 - Upon receipt of a petition filed under paragraph (1), the court shall consider the petition along with any answer filed by the Commonwealth and shall conduct a hearing thereon.
 - In any hearing on a petition for postconviction relief filed under paragraph (1), the court shall determine whether the exculpatory evidence resulting from the DNA testing conducted under this section would have changed the outcome of the trial as required by section 9543(a)(2)(vi).
 - (4) If testing complies with Federal Bureau of Investigation requirements and the data meets NDIS criteria, profiles obtained from the testing shall be searched or uploaded to CODIS.
- (5) When testing is conducted by a private laboratory, a court may order a public laboratory with access to CODIS to take the necessary measures to ensure the DNA profile 25 obtained from probative biological material from crime scene 26 evidence can be uploaded to CODIS by the public laboratory. 27 Necessary measures may include requiring the public laboratory to conduct a review of the private laboratory's facilities or records to ensure that the private laboratory complies with Federal Bureau of Investigation requirements
