AN ACT

- Amending the act of June 3, 1937 (P.L.1333, No.320), entitled "An act concerning elections, including general, municipal, special and primary elections, the nomination of candidates, 3 primary and election expenses and election contests; creating 4 and defining membership of county boards of elections; 5 imposing duties upon the Secretary of the Commonwealth, 6 courts, county boards of elections, county commissioners; imposing penalties for violation of the act, and codifying, 7 8 revising and consolidating the laws relating thereto; and repealing certain acts and parts of acts relating to 9 10 elections, " in nomination of candidates, further providing 11 for number of signers required for nomination petitions of 12 candidates at primaries. 13 The General Assembly of the Commonwealth of Pennsylvania 14 hereby enacts as follows:
- 16 Section 1. Section 912.1(32) of the act of June 3, 1937
- 17 (P.L.1333, No.320), known as the Pennsylvania Election Code, is

- 19 Section 912.1. Number of Signers Required for Nomination

- 1 Petitions of Candidates at Primaries. -- Candidates for nomination
- 2 of offices as listed below shall present a nominating petition
- 3 containing at least as many valid signatures of registered and
- 4 enrolled members of the proper party as listed below:
- 5 * * *
- 6 (32) [Office of district justice: One hundred.] Office of
- 7 magisterial district judge: One hundred, but only for a
- 8 candidate's primary election when the candidate does not already
- 9 <u>hold the office of magisterial district judge. A sitting</u>
- 10 magisterial district judge elected to the office shall not be
- 11 required to file a nominating petition under this section to
- 12 appear on the ballot for each party for the office of
- 13 magisterial district judge but may instead file a certificate of
- 14 <u>nomination for reelection specifying the intent to seek</u>
- 15 <u>reelection to the office. The provisions of this paragraph are</u>
- 16 <u>intended to assist in ensuring the safety of magisterial</u>
- 17 district judges and integrity of magisterial district courts.

- 19 Section 2. This act shall take effect in 60 days.
