## AN ACT

- 1 Providing for leave for blood donation for State and school 2 employees.
- 3 The General Assembly of the Commonwealth of Pennsylvania
- 4 hereby enacts as follows:
- 5 Section 1. Short title.
- 6 This act shall be known and may be cited as the State and
- 7 School Employee Blood Donation Act.
- 8 Section 2. Definitions.
- 9 The following words and phrases when used in this act shall
- 10 have the meanings given to them in this section unless the
- 11 context clearly indicates otherwise:
- 12 "Employee." An employee employed by the Commonwealth,
- 13 including an employee under the jurisdiction of the Governor,
- 14 General Assembly or judiciary and an employee of a school
- 15 district or institution of higher education.
- 16 "Institution of higher education." The term includes:
- 17 (1) A community college operating under Article XIX-A of

- 1 the act of March 10, 1949 (P.L.30, No.14), known as the
- 2 Public School Code of 1949.
- 3 (2) A university within the State System of Higher
- 4 Education.
- 5 (3) The Pennsylvania State University.
- 6 (4) The University of Pittsburgh.
- 7 (5) Temple University.
- 8 (6) Lincoln University.
- 9 (7) Any other institution that is designated as "State-
- 10 related" by the Commonwealth.
- 11 Section 3. Blood donor leave.
- 12 (a) Leave request. -- Except as provided under subsection (c),
- 13 all employees may request and shall be granted two consecutive
- 14 hours in a workday to serve as a voluntary blood donor if the
- 15 employee provides written verification from the physician of the
- 16 individual or the facility involved with the blood donation that
- 17 the employee will serve as a voluntary blood donor. An employee
- 18 may submit a request for leave of absence under this section no
- 19 more than four times in one calendar year.
- 20 (b) Compensation and protections. -- An employee who is
- 21 granted a leave of absence under this section shall receive
- 22 leave without loss of seniority, pay, vacation time, personal
- 23 days, sick leave, insurance and health coverage benefits or
- 24 earned overtime accumulation. The employee shall be compensated
- 25 at the employee's regular rate of pay for the regular work hours
- 26 during which the employee is absent from work.
- 27 (c) Collective bargaining. -- A collective bargaining
- 28 agreement which covers employees may provide more leave than is
- 29 granted under this act.
- 30 (d) Eligibility. -- For the duration of time that an employee

- 1 is deemed to be on leave under this act, the employee may not be
- 2 deemed an employee of the Commonwealth for the purposes of
- 3 workers' compensation coverage under the act of June 2, 1915
- 4 (P.L.736, No.338), known as the Workers' Compensation Act.
- 5 Section 4. Effective date.
- 6 This act shall take effect in 90 days.
