AN ACT

1 Providing for the capital budget for fiscal year 2024-2025;
2 itemizing public improvement projects, furniture and
3 equipment projects, transportation assistance, redevelopment
4 assistance projects, flood control projects and Pennsylvania
5 Fish and Boat Commission projects leased or assisted by the
6 Department of General Services and other State agencies,
7 together with their estimated financial costs; authorizing
8 the incurring of debt without the approval of the electors
9 for the purpose of financing the projects to be constructed,
10 acquired or assisted by the Department of General Services
11 and other State agencies; authorizing the use of current
12 revenue for the purpose of financing the projects to be
13 constructed, acquired or assisted by the Department of
14 General Services and other State agencies stating the
15 estimated useful life of the projects; and making
16 appropriations.

17 The General Assembly of the Commonwealth of Pennsylvania
18 hereby enacts as follows:

19 Section 1. Short title.

20 This act shall be known and may be cited as the Capital
21 Budget Project Itemization Act of 2024-2025.

22 Section 2. Total authorizations.

23 (a) Public improvements.--The total authorization for the
24 additional capital projects in the category of public
25 improvement projects itemized in section 3 and to be acquired or

1 constructed by the Department of General Services, its
2 successors or assigns, and to be financed by the incurring of
3 debt shall be \$14,578,105,000.

4 (b) Furniture and equipment.--The total authorization for
5 the additional capital projects in the category of public
6 improvement projects consisting of the acquisition of original
7 movable furniture and equipment to complete public improvement
8 projects itemized in section 4 and to be acquired by the
9 Department of General Services, its successors or assigns, and
10 to be financed by the incurring of debt shall be \$349,594,000.

11 (c) Transportation assistance.--The total authorization for
12 the capital projects in the category of transportation
13 assistance projects itemized in section 5 with respect to which
14 an interest is to be acquired in or constructed by the
15 Department of Transportation, its successors or assigns and to
16 be financed by the incurring of debt shall be \$1,300,000,000.

17 (d) Redevelopment assistance.--The total authorization for
18 the capital projects in the category of redevelopment capital
19 projects itemized in section 6 for capital grants by the
20 Department of Community and Economic Development, its successors
21 or assigns and to be financed by the incurring of debt shall be
22 \$0.

23 (e) Flood control.--The total authorization for the capital
24 projects in the category of flood control projects itemized in
25 section 7 and to be constructed by the Department of
26 Environmental Protection, its successors or assigns and to be
27 financed by the incurring of debt shall be \$9,900,000.

28 (f) Fish Fund and Boat Fund.--The total authorization for
29 the capital projects in the category of public improvement
30 projects itemized in section 8 to be acquired or developed by

1 the Pennsylvania Fish and Boat Commission and to be financed by
2 the incurring of debt or by current revenues of the Fish Fund
3 and the Boat Fund pursuant to executive authorization shall be
4 \$173,000,000.

5 Section 3. Itemization of public improvement capital projects.

6 Additional capital projects in the category of public
7 improvement projects to be acquired or constructed by the
8 Department of General Services, its successors or assigns, and
9 to be financed by the incurring of debt, are hereby itemized,
10 together with their respective estimated financial costs, as

29 Section 9. Debt authorization.

30 (a) Public improvements.--The Governor, Auditor General and

1 State Treasurer are hereby authorized and directed to borrow
2 from time to time in addition to any authorization heretofore or
3 hereafter enacted, on the credit of the Commonwealth, subject to
4 the limitations provided in the current capital budget, money
5 not exceeding in the aggregate the sum specified in section
6 2(a).

7 (b) Furniture and equipment.--The Governor, Auditor General
8 and State Treasurer are hereby authorized and directed to borrow
9 from time to time in addition to any authorization heretofore or
10 hereafter enacted on the credit of the Commonwealth, subject to
11 the limitations provided in the current capital budget, money
12 not exceeding in the aggregate the sum specified in section 2(b)
13 as may be found necessary to carry out the acquisition and
14 construction of the public improvement projects consisting of
15 the acquisition of original movable furniture and equipment
16 specifically itemized in the capital budget.

17 (c) Transportation assistance.--The Governor, Auditor
18 General and State Treasurer are hereby authorized and directed
19 to borrow from time to time in addition to any authorization
20 heretofore or hereafter enacted, on the credit of the
21 Commonwealth, subject to the limitations provided in the current
22 capital budget, money not exceeding in the aggregate the sum
23 specified in section 2(c) as may be found necessary to carry out
24 the acquisition and construction of the transportation
25 assistance projects specifically itemized in a capital budget.

26 (d) Redevelopment assistance.--Subject to the limitations in
27 section 2.1 of the act of May 29, 2020 (P.L.205, No.25), known
28 as the Capital Budget Act of 2019-2020, the Governor, Auditor
29 General and State Treasurer are hereby authorized and directed
30 to borrow from time to time in addition to any authorization

1 heretofore or hereafter enacted on the credit of the
2 Commonwealth, subject to the limitations provided in the current
3 capital budget, money not exceeding in the aggregate the sum
4 specified in section 2(d) as may be found necessary to carry out
5 the redevelopment assistance capital projects specifically
6 itemized in the capital budget.

7 (e) Flood control.--The Governor, Auditor General and State
8 Treasurer are hereby authorized and directed to borrow from time
9 to time in addition to any authorization heretofore or hereafter
10 enacted, on the credit of the Commonwealth, subject to the
11 limitations provided in the current capital budget, money not
12 exceeding in the aggregate the sum specified in section 2(e) as
13 may be found necessary to carry out the acquisition and
14 construction of the flood control projects specifically itemized
15 in a capital budget.

16 (f) Pennsylvania Fish and Boat Commission projects.--The
17 Governor, Auditor General and State Treasurer are hereby
18 authorized and directed to borrow from time to time in addition
19 to any authorization heretofore or hereafter enacted, on the
20 credit of the Commonwealth, subject to the limitations provided
21 in the current capital budget, money not exceeding in the
22 aggregate specified in section 2(f) to carry out the acquisition
23 and construction of the Pennsylvania Fish and Boat Commission
24 projects specifically itemized in a capital budget.

25 Section 10. Issue of bonds.

26 The indebtedness authorized in this act shall be incurred
27 from time to time and shall be evidenced by one or more series
28 of general obligation bonds of the Commonwealth in such
29 aggregate principal amount for each series as the Governor, the
30 Auditor General and the State Treasurer shall determine, but the

1 latest stated maturity date shall not exceed the estimated
2 useful life of the projects being financed as stated in section
3 11.

4 Section 11. Estimated useful life and term of debt.

5 (a) Estimated useful life.--The General Assembly states that
6 the estimated useful life of the capital projects itemized in
7 this act is as follows:

8 (1) Public improvement projects, 30 years.

9 (2) Furniture and equipment, 10 years.

10 (3) Transportation assistance projects:

11 (i) Rolling stock, 15 years.

12 (ii) Passenger buses, 12 years.

13 (iii) Furniture and equipment, 10 years.

14 (iv) All others, 30 years.

15 (4) Redevelopment assistance projects, 30 years.

16 (b) Term of debt.--The maximum term of the debt authorized
17 to be incurred under this act is 30 years.

18 Section 12. Appropriations.

19 (a) Public improvements.--The net proceeds of the sale of
20 the obligations authorized in this act are hereby appropriated
21 from the Capital Facilities Fund to the Department of General
22 Services in the maximum amount specified in section 2(a) to be
23 used by it exclusively to defray the financial cost of the
24 public improvement projects specifically itemized in a capital
25 budget. After reserving or paying the expenses of the sale of
26 the obligation, the State Treasurer shall pay to the Department
27 of General Services the money as required and certified by it to
28 be legally due and payable.

29 (b) Furniture and equipment.--The net proceeds of the sale
30 of the obligations authorized in this act are hereby

1 appropriated from the Capital Facilities Fund to the Department
2 of General Services in the maximum amount specified in section
3 2(b) to be used by it exclusively to defray the financial cost
4 of the public improvement projects consisting of the acquisition
5 of original movable furniture and equipment specifically
6 itemized in a capital budget. After reserving or paying the
7 expenses of the sale of the obligation, the State Treasurer
8 shall pay to the Department of General Services the money as
9 required and certified by it to be legally due and payable.

10 (c) Transportation assistance.--The net proceeds of the sale
11 of the obligations authorized in this act are hereby
12 appropriated from the Capital Facilities Fund to the Department
13 of Transportation in the maximum amount specified in section
14 2(c) to be used by it exclusively to defray the financial cost
15 of the transportation assistance projects specifically itemized
16 in a capital budget. After reserving or paying the expenses of
17 the sale of the obligation, the State Treasurer shall pay to the
18 Department of Transportation the money as required and certified
19 by it to be legally due and payable.

20 (d) Redevelopment assistance.--The net proceeds of the sale
21 of the obligations authorized in this act are hereby
22 appropriated from the Capital Facilities Fund to the Department
23 of Community and Economic Development in the maximum amount
24 specified in section 2(d) to be used by it exclusively to defray
25 the financial cost of the redevelopment assistance capital
26 projects specifically itemized in a capital budget. After
27 reserving or paying the expenses of the sale of the obligation,
28 the State Treasurer shall pay to the Department of Community and
29 Economic Development the money as required and certified by it
30 to be legally due and payable.

1 (e) Flood control.--The net proceeds of the sale of the
2 obligations authorized in this act are hereby appropriated from
3 the Capital Facilities Fund to the Department of Environmental
4 Protection in the maximum amount specified in section 2(e) to be
5 used by it exclusively to defray the financial cost of the flood
6 control projects specifically itemized in a capital budget.
7 After reserving or paying the expenses of the sale of the
8 obligation, the State Treasurer shall pay to the Department of
9 Environmental Protection the money as required and certified by
10 it to be legally due and payable.

11 Section 13. Federal funds.

12 (a) Projects itemized in this act.--All money received from
13 the Federal Government for the projects specifically itemized in
14 this act are also hereby appropriated for those projects.

15 (b) Projects not requiring itemization.--Department of
16 Military and Veterans Affairs construction projects which are
17 totally federally funded and to be administered by the
18 Department of General Services are hereby authorized.

19 Section 14. Editorial changes.

20 In editing and preparing this act for printing following the
21 final enactment, the Legislative Reference Bureau shall insert
22 or revise letters or numbers for projects where the letters or
23 numbers are missing or require revision. The Legislative
24 Reference Bureau shall also revise the total monetary amounts
25 for the total authorization, debt authorization, appropriations
26 and department totals as necessary to agree with the total
27 monetary amounts of the projects.

28 Section 15. Effective date.

29 This act shall take effect immediately.
