## AN ACT

1 2 3	Amending Title 75 (Vehicles) of the Pennsylvania Consolidated Statutes, in licensing of drivers, further providing for application for driver's license or learner's permit.
4	The General Assembly of the Commonwealth of Pennsylvania
5	hereby enacts as follows:
6	Section 1. Section 1506(b) of Title 75 of the Pennsylvania
7	Consolidated Statutes is amended and the section is amended by
8	adding subsections to read:
9	§ 1506. Application for driver's license or learner's permit.

11	[(b) Signature and certificationThe application shall be
12	signed by the applicant who shall certify that the statements
13	made are true and correct.]
14	(b.1) Compliance with Federal Selective Service ActThe
15	following shall apply:
16	(1) Any individual between 18 and 26 years of age who
17	applies for a driver's license or learner's permit and is
18	required to register with the Selective Service System in

1	compliance with the requirements of section 3 of the Military
2	<u>Selective Service Act (62 Stat. 604, 50 U.S.C. §</u>
3	3801 et seq.) may consent to registration by the department
4	by checking the box provided on the application for such
5	purpose.
6	(2) The department shall place the check-off box
7	described under paragraph (1) and the following statement on
8	the application:
9	Failure to register with the Selective Service System, if
10	required by Federal law, is a felony punishable by up to
11	<u>5 years imprisonment or a \$250,000 fine, or both. By</u>
12	checking the above box, I am consenting to registration
13	with the Selective Service System. For applicants who
14	object to conventional military service for religious or
15	other conscientious reasons, alternative service
16	information is available from the Selective Service
17	System's publicly accessible Internet website.
18	(3) An application for a driver's license or learner's
19	permit may not be denied by the department if the applicant
20	declines to consent to registration with the Selective
21	<u>Service System.</u>
22	(4) The department shall forward, in electronic format
23	to the Selective Service System, the necessary personal
24	information of the consenting applicants required to comply
25	with the Military Selective Service Act.
26	(5) The department shall enter into an agreement with
27	the Selective Service System which provides for reimbursement
28	of the Motor License Fund by the Selective Service System for
29	the department's actual costs incurred in the development and
30	implementation of the electronic transfer of information to

2 <u>other details relating to the development and implementation,</u>

3 <u>as necessary, including the frequency of providing</u>

4 <u>information to the Selective Service System.</u>

- 5 (c) Signature and certification.--The application shall be
- 6 signed by the applicant who shall certify that the statements
- 7 <u>made are true and correct.</u>
- 8 Section 2. This act shall take effect in nine months.
