AN ACT

- 1 Establishing the Rare Disease Advisory Council and providing for
- its powers and duties; and providing for duties of the
- Department of Health, the Insurance Department, the
- 4 Department of Human Services and the Department of Education.
- 5 The General Assembly of the Commonwealth of Pennsylvania
- 6 hereby enacts as follows:
- 7 Section 1. Short title.
- 8 This act shall be known and may be cited as the Rare Disease
- 9 Advisory Council Act.
- 10 Section 2. Definitions.
- 11 The following words and phrases when used in this act shall
- 12 have the meanings given to them in this section unless the
- 13 context clearly indicates otherwise:
- 14 "Advisory council." The Rare Disease Advisory Council
- 15 established in section 3.
- 16 "Department." The Department of Health of the Commonwealth.
- 17 "Rare disease." A disease or condition that affects fewer
- 18 than 200,000 individuals living in the United States.

- 1 "Secretary." The Secretary of Health of the Commonwealth.
- 2 Section 3. Establishment and membership.
- 3 (a) Establishment.--The Rare Disease Advisory Council is
- 4 established.
- 5 (b) Members.--The advisory council shall consist of the
- 6 following members:
- 7 (1) The secretary or a designee authorized to act on
- 8 behalf of the secretary.
- 9 (2) The heads of State agencies that may be concerned
- 10 with the provision of care to persons with rare diseases or
- designees authorized to act on behalf of the agency heads. At
- 12 a minimum, members under this paragraph shall include the
- 13 Secretary of Human Services and the Secretary of Education or
- 14 their respective designees.
- 15 (3) The Insurance Commissioner or a designee authorized
- to act on behalf of the Insurance Commissioner.
- 17 (4) Public members to be appointed by the secretary, who
- 18 shall include:
- 19 (i) Three physicians licensed to practice in this
- 20 Commonwealth who have expertise in the diagnosis and
- 21 management of patients with rare diseases, one of whom
- shall be a pediatrician who provides care to children
- 23 with rare diseases.
- 24 (ii) Two registered professional nurses or nurse
- 25 practitioners licensed in this Commonwealth who have
- 26 expertise in providing care to patients with rare
- diseases.
- 28 (iii) An epidemiologist licensed in this
- 29 Commonwealth who has expertise in the incidence,
- prevalence and control of rare diseases.

- 1 (iv) Two representatives of hospitals in this
- 2 Commonwealth, one of which must be a research hospital.
- 3 (v) Two representatives of the health insurance
- 4 industry.
- 5 (vi) Two representatives involved in the
- 6 biopharmaceutical industry.
- 7 (vii) Two representatives of the scientific
- 8 community who are engaged in rare disease research.
- 9 (viii) Two parents, each of whom has a child with a
- 10 rare disease, not of the same family.
- 11 (ix) Two individuals with rare diseases.
- 12 (x) Representatives of two rare disease-specific
- patient organizations that operate within this
- 14 Commonwealth.
- 15 (c) Additional members. -- The advisory council may at any
- 16 time advise the department on additional at-large appointments
- 17 to the advisory council that may be necessary to carry out its
- 18 duties. At-large appointees to the advisory council may serve on
- 19 an ad hoc basis.
- 20 (d) Vacancies. -- Vacancies in the membership of the advisory
- 21 council shall be filled in the same manner as provided for the
- 22 original appointments.
- 23 (e) Appointment of public members and chairperson. -- The
- 24 secretary shall appoint the public members of the advisory
- 25 council and a chairperson of the advisory council within 60 days
- 26 of the effective date of this section.
- 27 (f) Compensation. -- The public members of the advisory
- 28 council shall serve without compensation but may be reimbursed
- 29 for travel and other miscellaneous expenses necessary to perform
- 30 their duties within the limits of funds made available to the

- 1 advisory council for its purposes. Reimbursement for expenses
- 2 incurred by public members of the advisory council shall be
- 3 provided by the department according to standard criteria
- 4 currently in existence.
- 5 (g) Meetings. -- The advisory council shall meet periodically,
- 6 at a minimum of three times each year. A member may participate
- 7 in a meeting by teleconference. The initial meeting of the
- 8 advisory council shall be held within 90 days of the effective
- 9 date of this section.
- 10 (h) Assistance of other government agencies. -- The advisory
- 11 council shall be entitled to call to its assistance and avail
- 12 itself of the services of the employees of any State or local
- 13 government agency as it may require and as may be available to
- 14 it for its purposes.
- 15 (i) Staff.--The department may provide staff services to the
- 16 advisory council, including providing a secretary to the
- 17 advisory council.
- 18 Section 4. Purpose and duties.
- 19 (a) Purpose. -- The purpose of the advisory council is to:
- 20 (1) Coordinate Statewide efforts for the study of the
- 21 incidence and prevalence of rare diseases within this
- 22 Commonwealth and the status of the rare disease community.
- 23 (2) Act as the advisory body on rare diseases to the
- 24 General Assembly and to all relevant State and private
- agencies that provide services to, or are charged with the
- 26 care of, individuals with rare diseases.
- 27 (3) Coordinate the performance of the advisory council's
- duties with those of other rare disease advisory bodies and
- 29 community-based organizations and other public and private
- 30 organizations within this Commonwealth for the purpose of

- 1 ensuring greater cooperation between the entities within this
- 2 Commonwealth and Federal agencies regarding the research,
- diagnosis and treatment of rare diseases. For purposes of
- 4 this paragraph, Federal agencies may include, but are not
- 5 limited to, the National Institutes of Health and the Food
- 6 and Drug Administration. The coordination shall require, when
- 7 appropriate:
- 8 (i) Disseminating the outcomes of the advisory
- 9 council's research, identified best practices and policy
- 10 recommendations.
- 11 (ii) Utilizing common research collection and
- 12 dissemination procedures.
- 13 (b) Duties. -- The duties of the advisory council are to:
- 14 (1) Research and determine the most appropriate method
- to collect rare disease data, and information concerning
- individuals with rare diseases, as the advisory council deems
- 17 necessary and appropriate to conduct comprehensive surveys of
- rare diseases diagnosed in this Commonwealth, subject to all
- 19 applicable privacy laws and protections.
- 20 (2) Ensure that the duties described in subsection (a)
- 21 (1) are carried out in a manner that is coordinated and
- 22 interoperable with other similar research being conducted at
- the Federal and State level.
- 24 (3) Research and identify priorities relating to the
- 25 quality and cost effectiveness of and access to treatment and
- other services provided to individuals with rare diseases in
- this Commonwealth and develop policy recommendations on those
- issues.
- 29 (4) Identify best practices in other states and at the
- 30 national level for rare disease management, monitoring and

- 1 surveillance, education, detection, diagnosis, information
- 2 and care to improve these functions and capabilities relative
- 3 to rare diseases within this Commonwealth.
- 4 (5) Develop effective strategies to raise public
- 5 awareness of rare diseases within this Commonwealth.
- 6 (6) Coordinate the development of a task force,
- 7 comprised of members of the advisory council and other
- 8 individuals as may be necessary and appropriate to facilitate
- 9 the development and publication of the report specified in
- 10 section 6(b).
- 11 (c) Construction. -- Nothing in this act shall be construed to
- 12 prohibit the advisory council from issuing interim reports or
- 13 taking interim actions should these seem appropriate.
- 14 Section 5. Funding.
- 15 (a) Report to General Assembly. -- Prior to appointing members
- 16 of the advisory council, the department shall research and
- 17 report to the General Assembly within 30 days of the effective
- 18 date of this section existing sources of funding that may be
- 19 used to finance the formation and operation of the advisory
- 20 council.
- 21 (b) Grant and other funding. -- The advisory council shall
- 22 apply for, and is authorized to accept, a grant of money from
- 23 the Federal Government, a private foundation or any other source
- 24 which may be available for programs related to rare diseases.
- 25 Section 6. Reports.
- 26 (a) Preliminary report. -- Within 12 months of the effective
- 27 date of this section, the advisory council shall deliver to the
- 28 Public Health and Welfare Committee of the Senate and the Health
- 29 Committee of the House of Representatives a preliminary report
- 30 on the work of the advisory council. The report shall be made

- 1 available to the public. The report shall include a summary of
- 2 the accomplishments of the advisory council since its formation
- 3 and the status of its work in preparation of the report required
- 4 under subsection (b).
- 5 (b) Report.--Within two years of the effective date of this
- 6 section, the advisory council shall deliver to the Public Health
- 7 and Welfare Committee of the Senate and the Health Committee of
- 8 the House of Representatives a comprehensive report. The report
- 9 shall be made available to the public. The report shall include
- 10 the following:
- 11 (1) The incidence and prevalence of rare diseases within
- 12 this Commonwealth.
- 13 (2) The needs of the rare disease community within this
- 14 Commonwealth and the actions necessary and feasible to
- 15 address those needs.
- 16 (c) Biennial reports. -- The advisory council shall report
- 17 biennially to the department, the Public Health and Welfare
- 18 Committee of the Senate and the Health Committee of the House of
- 19 Representatives on the activities of the advisory council and
- 20 its findings and recommendations on issues relating to the
- 21 management, monitoring and surveillance, education, detection,
- 22 diagnosis, information and care regarding rare diseases in this
- 23 Commonwealth, including the quality and cost effectiveness of
- 24 care, access to treatment and other relevant services for
- 25 individuals affected by rare diseases.
- 26 Section 7. Expiration.
- This act shall expire June 30, 2025.
- 28 Section 8. Effective date.
- 29 This act shall take effect immediately.
