Amending Title 75 (Vehicles) of the Pennsylvania Consolidated Statutes, in licensing of drivers, further providing for 1 2 schedule of convictions and points; and, in rules of the road 3 in general, further providing for meeting or overtaking 5 school bus. 6 The General Assembly of the Commonwealth of Pennsylvania 7 hereby enacts as follows: 8 Section 1. Sections 1535(a) and 3345(j) of Title 75 of the Pennsylvania Consolidated Statutes are amended to read: 10 § 1535. Schedule of convictions and points. 11 General rule. -- A point system for driver education and 12 control is hereby established which is related to other 13 provisions for use, suspension and revocation of the operating 14 privilege as specified under this title.
