6	(c) Issuance of markers and licenses or road tax
7	registration cards

9	(3) The following shall apply:
10	(i) The Department of Revenue, in consultation with
11	the department, shall permit an online messenger to:
12	(A) Issue and renew identification markers,
13	licenses and road tax registration cards authorized
14	by this chapter.
15	(B) Issue temporary permits that authorize the
16	operation of qualified motor vehicles pending
17	issuance of permanent identification markers.
18	(C) Process applications related to the issuance
19	of items listed under clauses (A) and (B).
20	(D) Collect fees authorized by this chapter and
21	remit the fees to the Department of Revenue.
22	(ii) An online messenger who issues items authorized
23	<u>under subparagraph (i) shall:</u>
24	(A) Furnish and maintain a bond indemnifying the
25	public and the Department of Revenue in an amount
26	specified by the Department of Revenue.

3	with the department, shall promulgate regulations to
4	implement and enforce this paragraph.
5	(iv) In order to facilitate the prompt
6	implementation of this paragraph, regulations promulgated
7	by the department under this paragraph during the two
8	years following the effective date of this section shall
9	be deemed temporary regulations, which shall expire no
10	later than four years following the effective date of
11	this paragraph or upon promulgation of final regulations,
12	whichever occurs first. The temporary regulations shall
