AN ACT

Amending the act of April 12, 1951 (P.L.90, No.21), entitled, as reenacted, "An act relating to alcoholic liquors, alcohol and 2 malt and brewed beverages; amending, revising, consolidating 3 and changing the laws relating thereto; regulating and 4 restricting the manufacture, purchase, sale, possession, 5 consumption, importation, transportation, furnishing, holding 6 7 in bond, holding in storage, traffic in and use of alcoholic liquors, alcohol and malt and brewed beverages and the 8 persons engaged or employed therein; defining the powers and 9 duties of the Pennsylvania Liquor Control Board; providing 10 for the establishment and operation of State liquor stores, 11 for the payment of certain license fees to the respective 12 municipalities and townships, for the abatement of certain 13 nuisances and, in certain cases, for search and seizure 14 without warrant; prescribing penalties and forfeitures; 15 providing for local option, and repealing existing laws," 16 17 further providing for sales by liquor licensees and restrictions. 18 The General Assembly of the Commonwealth of Pennsylvania

- 20 hereby enacts as follows:
- 21 Section 1. Section 406(a) of the act of April 12, 1951
- 22 (P.L.90, No.21), known as the Liquor Code, reenacted and amended
- 23 June 29, 1987 (P.L.32, No.14), is amended by adding a paragraph
- 24 to read:

- 1 Section 406. Sales by Liquor Licensees; Restrictions.--(a)
- 2 * * *
- 3 (7) (i) Notwithstanding any provision of this act to the
- 4 contrary, the act by a bed and breakfast homestead or inn of
- 5 providing ONE BOTTLE OF wine to its paying guests AT CHECK-IN <--
- 6 while in an overnight status shall not be construed as the
- 7 direct or indirect sale of alcohol so long as that wine is
- 8 produced by a licensed limited winery as provided for under_
- 9 <u>section 505.2.</u>
- 10 (ii) For purposes of this paragraph, a "bed and breakfast
- 11 homestead or inn" shall mean a private residence that contains
- 12 ten or fewer bedrooms used for providing overnight
- 13 accommodations to the public and in which breakfast is the only
- 14 meal served and is included in the charge for the room.

- 16 Section 2. This act shall take effect immediately.
