25	The General Assembly of the Commonwealth of Pennsylvania
26	hereby enacts as follows:
27	Section 1. The act of April 9, 1929 (P.L.177, No.175), known
28	as The Administrative Code of 1929, is amended by adding a
29	section to read:

1	Section 2127. Local Health Department COVID-19 Antibody
2	<u>Testing(a) A health department may notify the secretary of</u>
3	the health department's intention to implement serology tests to
4	identify antibodies to the COVID-19 virus in coordination with
5	the guidance provided in the policy. Notification under this
6	subsection shall be made in writing to the secretary by the
7	<u>health director or equivalent employee of a health department.</u>
8	(b) Within seventy-two (72) hours of receipt of the
9	notification under subsection (a), the secretary shall
10	authorize, in writing, State laboratories holding a Clinical
11	Laboratory Improvement Amendments (CLIA) certificate and that
12	meet CLIA requirements to perform high-complexity testing, to
13	facilitate and coordinate testing with the respective health
14	department. The following shall apply:
15	(1) A health department shall reimburse a State laboratory
16	for costs incurred by the State laboratory for services
17	performed under this subsection.
18	(2) An individual tested under this subsection shall:
19	(i) Be notified in writing at the time of initial testing of
20	the applicable provisions of section (IV)(D) of the policy.
21	<u>(ii) Be advised of test results as soon as practicable in a</u>
22	manner determined by the health department.
23	(3) A health department performing serology tests under this
24	subsection shall report the total number of positive and
25	negative test results to the Department of Health of the
26	Commonwealth on a daily basis.
27	(c) This section shall expire sixty (60) days after the
28	expiration or termination of the proclamation of disaster
29	emergency issued by the Governor on March 6, 2020, published at
30	50 Pa.B. 1644 (March 21, 2020), and any renewal of the state of

2	(d) As used in this section, the following words and phrases
3	shall have the meanings given to them in this subsection unless
4	the context clearly indicates otherwise:
5	"Health department." A county or municipal health department
6	<u>in this Commonwealth.</u>
7	"Policy." The Policy for Diagnostic Tests for Coronavirus
8	Disease-2019 during the Public Health Emergency, docket number
9	FDA-2020-D-0987, available on the publicly accessible Internet
10	website of the Food and Drug Administration on March 16, 2020.
11	"Secretary." The Secretary of Health of the Commonwealth.
12	Section 2. This act shall take effect in 60 days.
