## AN ACT

Amending the act of June 19, 1931 (P.L.589, No.202), entitled, as amended, "An act to promote the public health and safety, by providing for the examination and licensure of those who desire to engage in the profession of barbering; regulating barber shops and barber schools, and students therein; regulating compensation for service rendered; conferring 5 6 certain powers and duties on the Department of State; and 7 providing penalties," further providing for licensure of manager-barbers and barber-teachers. 9 10 The General Assembly of the Commonwealth of Pennsylvania 11 hereby enacts as follows: 12 Section 1. Section 3(c) and (d) of the act of June 19, 1931 <--13 (P.L.589, No.202), referred to as the Barbers' License Law, 14 amended June 30, 1984 (P.L.494, No.101) and December 22, 2005 15 (P.L.446, No.84), are amended to read: 16 SECTION 1. SECTION 3(D) OF THE ACT OF JUNE 19, 1931 <--(P.L.589, NO.202), REFERRED TO AS THE BARBERS' LICENSE LAW, 17 18 AMENDED DECEMBER 22, 2005 (P.L.446, NO.84), IS AMENDED TO READ: Section 3. \* \* \* 19 20 (c) (1) Each applicant for a manager-barber's license

- 1 shall, as a condition precedent to obtaining a license, take the
- 2 manager barber's license examination and score a passing grade.
- 3 Prior to taking the examination, the applicant shall have
- 4 completed the eighth grade or its equivalent and actively
- 5 engaged in the practice of barbering, as a licensed barber, for-
- 6 one or more years. The board shall properly notify every
- 7 licensed barber that if he or she has been actively engaged in
- 8 the practice of barbering he or she shall, upon filing an-
- 9 application therefor prior to January 1, 1981, be licensed as a
- 10 manager barber without examination. A notarized application for
- 11 a license as a manager-barber shall be made in such form as the
- 12 board shall prescribe. The application shall be accompanied by a
- 13 notarized statement, from either the owner or manager of the
- 14 licensed barber shop or shared shop as set forth in section 15-
- 15 A.3 in which the applicant has been employed, that the applicant-
- 16 has been actively engaged in the practice of barbering, as a
- 17 licensed barber, for one or more years. The board shall not have
- 18 the power to require a photograph as part of an application for
- 19 a manager-barber's license. At the time of filing the-
- 20 application and accompanying notarized statement, the applicant-
- 21 shall pay to the department an examination fee to be determined
- 22 by regulation and shall present himself or herself at the next-
- 23 examination of applicants as provided in section 6.
- 24 (2) A barber licensee who possesses a minimum of three
- 25 years' experience or a manager barber licensee who possesses a
- 26 minimum of one year's experience as a manager barber as of
- 27 January 1, 2015, and has no record of disciplinary action, at
- 28 the expiration of the biennial licensure period next following
- 29 the effective date of this paragraph, may opt to become licensed
- 30 as a barber teacher without examination, upon application and

- 2 (d) [The] (1) EXCEPT AS PROVIDED IN PARAGRAPH (2), AN
- 3 applicant for a barber-teacher's license shall, as a condition

- 4 precedent to obtaining a license, take the barber-teacher's
- 5 license examination and score a passing grade. Prior to taking
- 6 the examination, the applicant shall be at least [twenty-three]
- 7 <u>eighteen</u> years of age, be a high school graduate or its
- 8 equivalent, and either have had five years' experience as a
- 9 licensed barber in a licensed barber shop or shared shop as set
- 10 forth in section 15-A.3 in Pennsylvania, or [be a manager-
- 11 barber] who has trained for [one thousand two hundred fifty
- 12 (1250)] <u>five hundred (500)</u> hours under a licensed teacher in a
- 13 licensed barber or cosmetology school as a teacher-trainee[.],
- 14 which hours shall be in addition to the hours necessary to
- 15 qualify for a license to practice barbering. The training shall
- 16 be limited to teaching methods and need not be specifically
- 17 related to barbering. A notarized application for a license as a
- 18 barber-teacher shall be made in such form as the board shall
- 19 prescribe. The application shall be accompanied by a notarized
- 20 statement, by either the owner or manager of the shop in which
- 21 the applicant has been employed that the applicant has had five
- 22 years experience as a licensed barber in a licensed barber shop
- 23 or shared shop as set forth in section 15-A.3 in this
- 24 Commonwealth or by the licensed barber school the teacher-
- 25 trainee attended, that the applicant has [been licensed as a
- 26 manager-barber and] trained for [one thousand two hundred fifty
- 27 (1250)] <u>five hundred (500)</u> hours under a licensed teacher in a
- 28 licensed barber or cosmetology school as a teacher-trainee. The
- 29 board shall not have the power to require a photograph as part
- 30 of an application for a barber-teacher's license. At the time of

- 1 filing the application and accompanying notarized statements,
- 2 the applicant shall pay to the department an examination fee to
- 3 be determined by regulation and shall present himself or herself
- 4 at the next examination of applicants as provided in section 6.
- 5 (2) AT THE EXPIRATION OF THE BIENNIAL RENEWAL PERIOD NEXT <-
- 6 FOLLOWING THE EFFECTIVE DATE OF THIS PARAGRAPH, A MANAGER-BARBER
- 7 LICENSEE WHO POSSESSES A MINIMUM OF THREE YEARS' EXPERIENCE AS A
- 8 MANAGER-BARBER AS OF JANUARY 1, 2015, AND HAS NO RECORD OF
- 9 <u>DISCIPLINARY ACTION MAY OPT TO BECOME LICENSED AS A BARBER-</u>
- 10 TEACHER WITHOUT MEETING THE TRAINING AND EXAMINATION
- 11 REQUIREMENTS IN PARAGRAPH (1), UPON APPLICATION AND PAYMENT OF
- 12 THE REQUIRED FEE.
- 13 Section 2. Section 3.2 of the act, amended June 30, 1984
- 14 (P.L.494, No.101), is amended to read:
- 15 Section 3.2. (a) If a licensed cosmetologist wishes to
- 16 become a licensed barber, he or she shall have successfully
- 17 completed the one thousand two hundred fifty (1,250)-hour
- 18 cosmetology training course or shall possess a current license
- 19 as a cosmetologist. Upon application to the board he or she
- 20 shall be given five hundred fifty-five (555) hours of credit for
- 21 subjects previously covered in the cosmetology training course,
- 22 which subjects shall be enumerated by joint regulation of the
- 23 State Board of Cosmetology and the board. Before such person is
- 24 permitted to take the barber practical and theory State Board
- 25 examination, he or she shall have successfully passed both the
- 26 theory and practical portions of the State Board of Cosmetology
- 27 examination.
- 28 (b) An individual currently holding both a cosmetology
- 29 <u>license and a barber's license may obtain a barber-teacher</u>
- 30 license if the individual completes the training and examination

- 1 required for licensure as either a barber-teacher or a
- 2 cosmetology teacher.
- 3 SECTION 3. SECTION 4(A) AND (B) OF THE ACT, AMENDED OCTOBER <--
- 4 16, 1980 (P.L.981, NO.168) AND JUNE 30, 1984 (P.L.494, NO.101),
- 5 ARE AMENDED TO READ:
- 6 SECTION 4. (A) A BARBER OR A BARBER-TEACHER CURRENTLY
- 7 LICENSED IN ANOTHER STATE WITH SUBSTANTIALLY THE SAME LICENSURE
- 8 REQUIREMENTS AS PENNSYLVANIA SHALL BE GRANTED A PENNSYLVANIA
- 9 BARBER OR BARBER-TEACHER LICENSE WITHOUT AN EXAMINATION UPON
- 10 PAYMENT OF THE FEE. THE AFORESAID PROVISION SHALL ONLY BE
- 11 EFFECTIVE WHEN A MUTUAL RECIPROCAL AGREEMENT HAS BEEN EXECUTED
- 12 BETWEEN THE RESPECTIVE STATE LICENSING BOARDS.
- 13 (B) A BARBER <u>OR BARBER-TEACHER</u> APPLICANT CURRENTLY LICENSED
- 14 IN ANOTHER STATE NOT RECOGNIZED BY A RECIPROCAL AGREEMENT SHALL
- 15 BE ELIGIBLE FOR THE BARBER OR BARBER-TEACHER EXAMINATION UPON
- 16 APPROVAL OF THE BOARD WHICH APPROVAL SHALL NOT BE ARBITRARILY
- 17 WITHHELD. THE EXAMINATION SHALL CONSIST OF BARBER LAW, RULES AND
- 18 REGULATIONS. SHOULD THE EXAMINEE FAIL TO PASS THE EXAMINATION,
- 19 UPON PAYMENT OF THE REQUIRED FEE, THE EXAMINEE MAY TAKE ANOTHER
- 20 EXAMINATION IF THE EXAMINEE SO DESIRES. IN NO EVENT SHALL THE
- 21 EXAMINEE BE PERMITTED TO PRACTICE BARBERING UNTIL THE EXAMINEE
- 22 HAS RECEIVED A BARBER'S LICENSE.

- Section 3 4. Section 13(a) of the act, amended December 7, <--
- 25 1994 (P.L.855, No.123), is amended to read:
- 26 Section 13. (a) No person shall practice barbering who is
- 27 not a licensed barber, with the exception that nonlicensed
- 28 persons may shampoo hair under the supervision of a barber-
- 29 manager [or], barber-owner or barber-teacher. No licensed barber
- 30 shall practice, or attempt to practice, barbering in any place

- 1 other than a licensed barber shop or licensed cosmetology shop,
- 2 except that any licensed barber in a licensed barber shop or
- 3 licensed cosmetology shop may furnish barber services to persons
- 4 at their place of residence or in institutions in cases of
- 5 sickness, incapacitation, confinement, and other emergencies:
- 6 Provided, however, That nothing contained in this section shall
- 7 be construed to include family members of the same household,
- 8 hospitals or colleges, and private schools for children,
- 9 cosmetology shops or schools of cosmetology, except that it
- 10 shall be unlawful and a violation of this act for any person to
- 11 employ or to accept employment, in any such shops, parlors or
- 12 schools, who has been refused a license by the board.

- Section 4 5. Section 13.1 of the act, added May 3, 1991 <--
- 15 (P.L.7, No.4), is amended to read:
- 16 Section 13.1. Upon payment of a required fee, a temporary
- 17 license may be issued to any applicant who is eligible for
- 18 admission to the barber's examination. An applicant who is thus
- 19 licensed shall practice only under the supervision of a licensed
- 20 manager-barber or barber-teacher until results are available
- 21 from the next scheduled examination. Temporary licenses are
- 22 granted for a nine-month period.
- Section 5 6. Section 15-A.3(b) of the act, amended June 14, <--
- 24 1991 (P.L.66, No.8), is amended to read:
- 25 Section 15-A.3. \* \* \*
- [(b) A barber shop licensee who shall employ a licensed
- 27 cosmetologist shall also be a licensed barber-manager or employ
- 28 a barber-manager.]

- 30 Section 6 7. This act shall take effect in 60 days.
