AN ACT

- Amending the act of April 9, 1929 (P.L.177, No.175), entitled, 1 as amended, "An act providing for and reorganizing the 2 conduct of the executive and administrative work of the 3 Commonwealth by the Executive Department thereof and the administrative departments, boards, commissions, and officers 5 thereof, including the boards of trustees of State Normal 6 Schools, or Teachers Colleges; abolishing, creating, 7 reorganizing or authorizing the reorganization of certain 8 administrative departments, boards, and commissions; defining 9 the powers and duties of the Governor and other executive and 10 administrative officers, and of the several administrative 11 departments, boards, commissions, and officers; fixing the 12 salaries of the Governor, Lieutenant Governor, and certain 13 other executive and administrative officers; providing for 14 the appointment of certain administrative officers, and of 15 all deputies and other assistants and employes in certain 16 departments, boards, and commissions; providing for judicial 17 administration; and prescribing the manner in which the 18 19 number and compensation of the deputies and all other assistants and employes of certain departments, boards and 20 commissions shall be determined," in Commonwealth budget procedures, providing for general appropriation bill 21 22 23 compensation suspension. - 26 Section 1. The act of April 9, 1929 (P.L.177, No.175), known
- 27 as The Administrative Code of 1929, is amended by adding a
- 2.8 section to read:

- 1 <u>Section 613.1. General Appropriation Bill Compensation</u>
- 2 <u>Suspension.--(a)</u> If a general appropriation bill is not enacted
- 3 by June 30 of a fiscal year for the subsequent fiscal year,
- 4 compensation and reimbursement for expenses, including per
- 5 diems, for the Governor, Lieutenant Governor, cabinet officers
- 6 and members of the General Assembly shall be suspended until a
- 7 general appropriation bill has been enacted.
- 8 (b) Compensation and reimbursement for expenses, including
- 9 per diems, suspended under subsection (a) shall be paid
- 10 retroactively to July 1 upon enactment of a general
- 11 <u>appropriation bill.</u>
- 12 Section 2. This act shall take effect immediately.
