AN ACT

- 1 Authorizing the Treasury Department to process Supplemental
- 2 Security Income State Supplement Payments for other states;
- providing for duties of the Treasury Department; and
- establishing the SSP Processing Account.
- 5 The General Assembly of the Commonwealth of Pennsylvania
- 6 hereby enacts as follows:
- 7 Section 1. Short title.
- 8 This act shall be known and may be cited as the Supplemental
- 9 Security Income State Supplement Payments for Out-of-State
- 10 Payors Act.
- 11 Section 2. Definitions.
- 12 The following words and phrases when used in this act shall
- 13 have the meanings given to them in this section unless the
- 14 context clearly indicates otherwise:
- 15 "Account." The SSP Processing Account established in section
- 16 4.
- 17 "Department." The Treasury Department of the Commonwealth.

- 1 Section 3. Processing of payments.
- 2 (a) General rule. -- The department may process Supplemental
- 3 Security Income State Supplement Payments for out-of-State
- 4 payors.
- 5 (b) Contracts.--The department may enter into contracts, on
- 6 a contingent fee or other basis, associated with or arising out
- 7 of the activities of the department under subsection (a).
- 8 Section 4. Account.
- 9 (a) Establishment.--There is established a restricted
- 10 account in the General Fund to be known as the SSP Processing
- 11 Account. The department shall credit to the account all funds
- 12 collected or received from processing Supplemental Security
- 13 Income State Supplement Payments for out-of-State payors. On
- 14 July 31 of each year, all funds in the account which have not
- 15 been appropriated by the General Assembly in accordance with
- 16 subsection (b) shall be transferred to the General Fund.
- 17 (b) Use. -- The General Assembly shall ANNUALLY appropriate

- 18 funds from the account to support the department's activities
- 19 under this act. The department shall submit a request for the
- 20 appropriation of the funds under Article VI of the act of April
- 21 9, 1929 (P.L.177, No.175), known as The Administrative Code of
- 22 1929. EACH ANNUAL APPROPRIATION FROM THE ACCOUNT SHALL LAPSE, IN <--
- 23 ACCORDANCE WITH SECTION 621 OF THE ACT OF APRIL 9, 1929
- 24 (P.L.177, NO.175), KNOWN AS THE ADMINISTRATIVE CODE OF 1929, TO
- 25 THE GENERAL FUND.
- 26 Section 5. Reporting.
- 27 The department shall, by March 31 of each year, issue a
- 28 report to the Governor, the majority chair and the minority
- 29 chair of the Appropriations Committee of the Senate and the
- 30 majority chair and minority chair of the Appropriations

- 1 Committee of the House of Representatives. The report shall
- 2 contain at least the following information FOR THE REPORTING <--
- 3 PERIOD:
- 4 (1) A REPORT OF ALL OF THE DEPARTMENT'S ACTIVITIES <--
- 5 UNDERTAKEN IN ACCORDANCE WITH THIS ACT.
- 6 (2) A LIST OF THE CONTRACTS AUTHORIZED UNDER SECTION
- 7 3(B).
- 8 (1) (3) A detailed breakdown ACCOUNTING of the
- 9 department's operating costs and other costs incurred for

- 10 activities authorized under this act for the 12 months prior
- 11 to the date of the report.
- 12 $\frac{(2)}{(4)}$ (4) The total revenue collected by the department
- for activities authorized under this act during the period
- 14 covered by the report.
- 15 (5) A detailed estimate of the department's
- operating costs and other costs for activities authorized
- 17 under this act for the next fiscal year that commences after
- 18 the date of the report, including the projected cost of a
- 19 contract authorized under section 3(b).
- 20 Section 6. Limitations.
- 21 The following shall apply to an activity authorized under
- 22 this act:
- 23 (1) Nothing under this act, including, but not limited
- 24 to, a contract authorized under this act and the processing
- of a Supplemental Security Income State Supplement Payment
- for out-of-State payors, shall be construed to permit or
- 27 authorize the waiver of sovereign immunity for the purposes
- of 1 Pa.C.S. § 2310 (relating to sovereign immunity
- 29 reaffirmed; specific waiver).
- 30 (2) Nothing under this act shall permit the department

- or the Commonwealth to indemnify another party for a loss,
- 2 damage or shortfall associated with a contract to process
- 3 Supplemental Security Income State Supplement Payments for
- 4 out-of-State payors.
- 5 Section 31. Appropriation.
- 6 For fiscal year 2014-2015, \$4,500,000 is appropriated on a
- 7 continuing basis from the account to the department to support
- 8 the department's activities under this act.
- 9 Section 32. Effective date.
- 10 This act shall take effect immediately.
