## AN ACT

- 1 Providing for regional response health collaborations to promote
  - health in facilities by supporting COVID-19 readiness and
- response and improving the quality of infection prevention  $\div$ ; <--
- 4 AND MAKING EMERGENCY APPROPRIATIONS FOR HUMAN SERVICES.
- 5 The General Assembly of the Commonwealth of Pennsylvania
- 6 hereby enacts as follows:

- 7 Section 1. Short title.
- 8 This act shall be known and may be cited as the Regional
- 9 Response Health Collaborative Act.
- 10 Section 2. Definitions.
- 11 The following words and phrases when used in this act shall
- 12 have the meanings given to them in this section unless the
- 13 context clearly indicates otherwise:
- "Assisted living residence." As defined in section 1001 of
- 15 the act of June 13, 1967 (P.L.31, No.21), known as the Human

- 2 "Authority." The Commonwealth Financing Authority.
  - "COVID-19." The novel coronavirus as identified in the

- 4 Governor's Proclamation of Disaster Emergency issued on March 6,
- 5 2020, published at 50 Pa.B. 1644 (March 21, 2020).
- 6 "DEPARTMENT." THE DEPARTMENT OF HUMAN SERVICES OF THE <--
- 7 COMMONWEALTH.
- 8 "Emergency medical services agency." As defined in 35
- 9 Pa.C.S. § 8103 (relating to definitions).
- 10 "Facility." Any of the following:
- 11 (1) An assisted living residence.
- 12 (2) A long-term care nursing facility.
- 13 (3) A personal care home.
- 14 "Federal funds." Funds received from the Federal Government
- 15 to fight COVID-19 under the Federal Coronavirus Aid, Relief, and
- 16 Economic Security Act (Public Law 116-136, 134 Stat. 281).
- 17 "Health collaborative." A collaboration of a local health
- 18 care system that provides educational support and clinical
- 19 coaching in a specific region of this Commonwealth.
- 20 "Long-term care nursing facility." As defined in section
- 21 802.1 of the act of July 19, 1979 (P.L.130, No.48), known as the
- 22 Health Care Facilities Act.
- "Personal care home." As defined in section 1001 of the
- 24 Human Services Code.
- 25 "Region." The following areas of this Commonwealth:
- 26 (1) Northeast.
- 27 (2) Southeast.
- 28 (3) North central.
- 29 (4) South central.
- 30 (5) Northwest.

- 1 (6) Southwest.
- 2 Section 3. Regional response health collaborative.
- 3 (a) Division.--The authority DEPARTMENT shall divide this <--
- 4 Commonwealth into regions and shall delineate all of the
- 5 facilities within the parameters of a region.
- 6 (b) Proposals.--The authority DEPARTMENT shall solicit <--
- 7 proposals from health collaboratives to provide operations,
- 8 management and administration of the purposes provided under
- 9 subsection (e) in each region to protect residents in facilities
- 10 from COVID-19.
- 11 (c) Contract. -- The authority DEPARTMENT, IN CONSULTATION <--
- 12 WITH THE SECRETARY OF HEALTH, shall contract with at least one
- 13 health collaborative in each region for the purposes provided
- 14 under subsection (e).
- 15 (d) Appropriation. -- The amount of \$500,000,000 of the
- 16 Federal funds is appropriated to the authority DEPARTMENT for

- 17 the purposes of this act. The <del>authority</del> DEPARTMENT shall
- 18 distribute the funds to each health collaborative contracted
- 19 under subsection (c).
- 20 (e) Purpose.--Each health <del>care</del> collaborative shall: <--
- 21 (1) Promote health and stabilize the economy of the
- region by directly supporting COVID-19 readiness and response
- 23 in facilities.
- 24 (2) Improve the quality of care related to infection
- 25 prevention and other priority health care conditions common
- 26 to facilities.
- 27 (3) Expand COVID-19 testing to include asymptomatic
- 28 staff and residents in facilities to expand public health
- 29 surveillance.
- 30 Section 4. Duties.

- 1 (a) Review.--Each health collaborative shall perform daily
- 2 strategic review of facilities in their region.
- 3 (b) Plan. -- Through collaborative review of the clinical
- 4 situation within facilities identified as having unmet needs, a
- 5 health collaborative shall formulate an action plan tailored to
- 6 the facility, identifying specific resources or tactical actions
- 7 to implement to assist facilities.
- 8 (c) Components. -- A health collaborative shall provide for
- 9 the following as provided under section 5:
- 10 (1) Enhanced testing capability.
- 11 (2) Infection control consultation and implementation,
- including contact tracing.
- 13 (3) Advanced clinical care, including remote monitoring
- and physician consultation.
- 15 (d) Funds. -- A health collaborative shall:
- 16 (1) budget for and distribute funds provided by the
- 17 authority DEPARTMENT; and
- 18 (2) track and record the expense associated with each

- 19 type of testing and with implementing infection control
- 20 consultation across the region.
- 21 Section 5. Components.
- 22 (a) Enhanced testing. --
- 23 (1) If a facility experiences a positive test of COVID-
- 24 19, testing of facility residents and health care workers
- shall be conducted. Onsite testing shall be made available
- through mobile testing teams developed by the health
- 27 collaborative. The health collaborative shall coordinate the
- testing response with participation from local emergency
- 29 medical services agencies and regional testing laboratories
- 30 to prioritize receipt of test results.

- 1 (2) A health collaborative shall deploy systematic
- 2 surveillance testing on a weekly basis using a random
- 3 sampling of not more than five asymptomatic residents in a
- 4 facility. Results of the testing shall be shared with all
- 5 stakeholders and the Commonwealth.
- 6 (b) Infection control and consultation. -- A health
- 7 collaborative shall deploy clinical staff to perform onsite
- 8 observation and consultation as part of the mobile testing team.
- 9 The clinical staff shall:
- 10 (1) implement infection control practices, such as
- 11 cohorting, personal protective equipment use, case detection
- 12 and staffing practices; and
- 13 (2) facilitate completion of exposure tracing studies.
- 14 (c) Advanced clinical management assistance. -- Clinical staff
- 15 shall provide onsite and telemedicine-supported clinical care
- 16 for a facility.
- 17 SECTION 6. EMERGENCY APPROPRIATIONS FOR HUMAN SERVICES.
- 18 (A) CONSTRUCTION WITH GENERAL APPROPRIATION ACT OF 2019.--
